2012/2013 FISCAL YEAR PRESIDENT'S REPORT

It is the philanthropic partnership with our generous donors, effective non-profits and supportive sponsors that enables Shuswap Community Foundation (SCF) to continue to thrive.

In the fiscal year 2012 - 2013 our total capital grew from \$4,948,144 to \$5,760,352 – a growth of \$812,208. We paid out \$155,000 in grants to non-profits and agencies within the Shuswap Region.

Most of the capital donated is in memory of a loved one or money donated to set up a family fund – a lasting legacy to the community. To me, these family funds are the very essence of Shuswap Community Foundation. A good example of this is a fund that was set up very recently in the memory of Garry Locke. Garry suffered from numerous physical ailments. He had a very hard time getting around. Nevertheless he was a very friendly and gregarious fellow and was well known around town for his significant contributions to several nonprofit groups. I got to know him through my involvement with SABNES. Whenever we crossed paths in town we would chat.

When Garry passed away, his family and friends set up a memorial fund in his name. The income from his fund will help organizations that support physically and mentally challenged people in the Shuswap. When we were signing the deed of gift, Garry's mother Bernice simply said "Garry would really like this" and from my experiences talking with Garry, I am sure she was right. This fund is not large and consists of many donations from his friends and family. When it reaches the \$10,000 mark, the income will be paid out to appropriate charitable organizations that apply for a grant. The fund is open to anyone who would like to contribute in Garry's memory. To me this fund truly signifies what we are all about – we keep memories alive, every donation big and small makes a difference, and we leave a lasting legacy to the community that we love.

This year will be a busy year as we will be preparing a Vital Signs Report for our community. This report will help identify areas of need within our region, which will help with our granting process. This will be my last year as President and I hope to concentrate my efforts in future on the completion of this report. Our Vice-President, Dave Wood, will step into the role of President.

I have enjoyed my role as President of Shuswap Community Foundation and would like to thank the Board of Directors for their support over the past years.

To our retiring board member Joanne Mason and to all friends of the Foundation: thank you for your commitment to community.

Born in Saskatchewan, Rosemarie moved to Salmon Arm in time to start school. She graduated from SASS, worked for a while, then married and raised daughters, Kathryn and Margaret. As a stay at home mom, she found many opportunities to volunteer. Once the girls graduated she reinvented herself in the workplace and continued to volunteer. Rosemarie loved working as the Salmar Theatre Manager for almost 20 years. She truly enjoyed the young people she worked with and embodied the Salmar philosophy of giving back to the community.

Family was Rosemarie Vennard's life. But her definition of family was much larger and included her community and the various groups she belonged to and volunteered with. Her families included: Salmon Arm Minor Girls Softball where she served as President, coach, equipment manager and cheerleader to ensure girls of all ages had opportunities to play; The First United church where she was counted on in many capacities; the Dove Rebekah Lodge with whom she was a 50 year member with time served in various offices; and the Senior's Drop in Centre Society where she organized Saturday night Bingos for many years to raise

money for community charities such as the SAFE House, Shuswap Search and Rescue, and Second Harvest.

Wherever a helping hand was needed, Rosemarie was there: canvassing for BC Heart & Stroke, Cancer Society and other charities. She helped with the Wendy's Dream Lift team, the Salvation Army's Christmas appeal, the Churches Thrift Shop, the Library, the Hospital and the annual Rotary Auction. She also helped individuals who needed a 'hand up' by giving them a low cost place to live in her home when they were down on their luck—single moms and dads, disabled individuals and students.

Her daughters praise her 'great laugh, stubborn tenacity, faith in humankind, green thumb, compassion enough for ten people, her positively positive can-do attitude and her good intentions'. to participate and enjoy themselves. Rosemarie loved working with young people and remained young at heart by injecting humour and fun into her own life and all those she touched.

One of her passions included environmentalism-she started recycling more than 40 years ago, before it became the 'right thing' to do. Continuing her Mother's legacy of service and the pay it forward philosophy, Kathryn initiated the "She Shoe Swaps" sale in 2012. The proceeds from this one-day sale of gently used or new shoes, boots and bags are evenly divided between the SAFE Society (Women's Shelter) and the Shuswap Community Foundation (Rosemarie's Fund).

Rosemarie's charitable works were like pebbles thrown into a lake creating interconnecting circles enriching her own life and that of her community in countless ways. With the establishment of Rosemarie's Fund, daughters Kathryn and Margaret have ensured that their mother's love and commitment to community continues in perpetuity. What a wonderful tribute to a remarkable woman!

CLARA ANDERSON ENDOWMENT FUND



Clara Anderson née Rabie has lived her entire life in the Shuswap. Born in the old Salmon Arm Hospital to parents George and Louise Rabie and raised in Sorrento, Clara graduated from Salmon Arm Senior Secondary in 1966. After obtaining her teaching degree, she taught in School District 83 for 34 years. In 1967 she married Elton Anderson. They have twin daughters, Melissa (Wood) and Jennifer (Wheeler), and four grandsons.

Born with an innate musical ability, as a young child she learned to play the piano 'by ear.' A neighbour loaned her an accordion that came with instruction books and teaching LPs, and before long, she was playing that accordion every chance she got. Today she has her own 'one woman' Black Velvet Band, and is in constant demand throughout the Shuswap and the Okanagan. In 2012, Clara achieved First Prize in her individual age category at the Kimberly International Old Time Accordion Championships. Also gifted with a beautiful soprano voice, Clara is a charter member of the Shuswap Singers, sang with the Monashee Chamber Choir until 2009 and has sung with the Northern Lights Chamber Choir since its inception in 2009. She credits Tom Brighouse for mentoring her, and encouraging her talent. "Having had the opportunity to work with such a talented musician, singer, and teacher meant a lot to this young girl from the country!"

In October 2012 Clara established the Clara Anderson Endowment Fund with the Shuswap Community Foundation. When the fund accumulates \$10,000 the interest earned will be disbursed annually to a person or persons of any age who demonstrates musical ability and a financial need. The fund is open to contributions from anyone who wishes to contribute.

WRESTLING WITH FUNDING

"It's not just about girls' basketball anymore," enthuses Rob Neid (SAS coach) pointing at the wall of ribbons, trophies and photos of the school's 30 athletic teams. Over the years, those teams have brought home 27 provincial championships. Not bad for a school population of 1200 students!

For many students like SAS' Shay-Lyn Steiger, (BC High School 2013 Provincial Wrestling Champion) being involved in school sports is key to a good high school experience. She says SAS Wrestling has helped her deal with life situations better: "It has made me a stronger person. It motivates me to be a better person".

The SAS athletic department knows a thing or two about wrestling, including wrestling with program funding. Did you know that no money is allocated for school athletic programs in the district's budget? With a fee of \$40 per student for each team, if you have a couple of athletic teens attending SAS you might be shelling out a couple of hundred bucks each year for team sports. Although fees can be waived in cases of financial hardship, it is likely that some students or parents just don't ask.

In 2009 the Salmon Arm Secondary Athletic Endowment Fund was established with the Foundation to provide income for athletic programs year in and year out. Thanks to the fund's Builders (\$1000 and over) and other generous donors, the fund now stands at slightly under \$25,000.

"Just imagine if we could grow this fund so that student fees for athletics are history!" exclaims Cindy Derkaz (Foundation-SAS Fund liaison).

NINA DICKINS FOUNDATION FOUNDER

Nina claims that "Salmon Arm found me" when asked how she happened to move here. Her route from England to Revelstoke as a lab technician and marriage to a 'fellow Brit', Ken, took her to St. Bruno, Quebec where she raised their two sons. They always had plans to move back to BC once Ken retired. But he passed away before they could fulfill that dream together.

Not every woman has the chance to reinvent herself and to realize some of life's dreams, but that is just what Nina did when, at age 58, she found herself alone in St. Bruno. After a skiing holiday with her sons at Silver Star in 1993 Nina explored Salmon Arm. Heron View was just under construction and as she stood in an unfinished house she had the feeling that this is where she should be, even though she knew no one in Salmon Arm.

The first new venture was to become trained as a hospice volunteer which led, in the spring of 1994, to Therapeutic Touch training. She found this helpful in her hospice work. This led to involvement in the 'Relaxation Support Group' started in 1999 to help patients deal with chronic illness. Nina has been the facilitator of this group for the last few years.

The second most important purchase after her house was a kayak. Her love of nature, hiking and camping was enriched when she became an ardent kayaker. Among her memorable kayak trips were Tonga to celebrate her 70th birthday and Belize with her son Mark to celebrate her 76th birthday.

Nina was able to realize a long-standing ambition soon after arriving in Salmon Arm: learning Tai chi. She was a keen and enthusiastic student taking extra classes and workshops whenever possible. Eventually she became a teacher herself and led a seniors class for many years.

In St. Bruno Nina had taught herself calligraphy and took weekend courses. Here she joined the Kelowna Calligraphers Guild and continued formal studies. She has taught workshops in Kelowna and still works on calligraphy commissions. A related interest is her membership in the 'International Decorative Envelope Exchange'.



Nina's many volunteer activities

include hosting at the Art Gallery, one on one reading with the Literacy Alliance and assisting with brain fitness courses. She has been a dragon boater and belongs to both book and journal clubs. Nina's interests and volunteer activities allowed her to integrate easily and she is a valued community member.

In late 1993, shortly after arriving in Salmon Arm, Nina met Lois Higgins just when Lois was looking for founders to provide seed money to start the Shuswap Community Foundation. The fledging organization's goals and purposes resonated with Nina who prefers a personal connection to some of the projects she supports with her charity dollars. So becoming one of the founders of the Shuswap Community Foundation was a perfect fit for this then new citizen of Salmon Arm.

DOROTHY LONGDO MEMORIAL BURSARY FUND

While attending high school in Maidstone, AB, Dorothy met Vernon Longdo, and after nine years of close friendship, they married in Edmonton in1957. Vern's career as a Mining Engineer took them to Elliot Lake, ON for three years, followed by three years in Labrador City, QC. From there they came west, to Penticton and then Vancouver, before settling in Calgary, AB in 1967 with their two children, Blair and Lianne.

Born in Ribstone, Alberta, Dorothy Genevieve Longdo née Tennant was the second oldest of eight siblings. After completing high school she attended Teacher's College in Saskatoon, SK, receiving her Teaching Certificate in 1951. During her teaching career, she taught primary grades in five provinces. Dorothy taught until1964.

Dorothy also possessed a beautiful singing voice. While still living and teaching in Saskatoon, she also taught music, and founded the Youth Choir at Victoria School, which continues to sing today. She was the soloist of choice at many weddings in her hometown of Maidstone.

While living in Calgary, Dorothy became a student again, earning a Bachelor of Arts in Education at age 50. Education was her passion, and she was a very effective, respected teacher everywhere she taught. While teaching in Edmonton, at the request of the University of Alberta, she was the role model with whom student teachers were placed to learn the art of teaching effectively.

Dorothy & Vern retired to Shuswap Lake Estates in 1986. She became a stalwart member of the Canadian Cancer Society



volunteer group in Sorrento, and in Salmon Arm. Never one to say 'no', Dorothy could always be counted on to carry out whatever task she was asked to do in a kind, caring and efficient manner. Her fellow volunteers also became her good friends.

Throughout their life together, Dorothy was always a full partner in everything she and Vern did. In honour of Dorothy, his life with her and the wonderful, compassionate person she was, Vern has established the Dorothy Longdo Memorial Bursary Fund. Each fall, the interest earned by the fund will be awarded to a student who meets the criteria set out in the fund's Deed of Gift, and who plans to continue his or her post secondary education.


A special child, Leonard Garry Locke was born in Langley in 1965 and moved to Salmon Arm with his parents, Bernice and Leonard Locke, in 1990. When his Mom & Dad moved back to Langley in 1994, Garry elected to stay in Salmon Arm, living with Peter Kuzek and his family for the next 19 years.

Garry loved hockey, and never missed a Salmon Arm Silverbacks game if he could help it. Upon his death in November of 2012, he was paid a tribute by the game's announcer, and accorded a minute of silence out of respect for his long-time support of the team.



REMEMBERING HARRY NAKAGAWA

All you need to do is take a stroll in picturesque McGuire Lake Park located in Downtown Salmon Arm and you'll quickly realize something quite special is happening by the Friendship Arch located on the grounds. Through a newly introduced walkway program, visitors to the park are being offered a glimpse into the celebrations and remembrances of those who have called this region their home. From significant birthdays to life's milestones (anniversaries, weddings, births, graduations) and recollections of lost loved ones, the McGuire Lake Memorial Walkway is filling up with warm and wonderful memories that are being permanently placed within the brick walkway. The first phase of the Walkway Program was jointly launched by Shuswap Community Foundation and the City of Salmon Arm in November of 2012.

Early in the Spring of 2013 the first engraved memorial bricks began appearing along the walkway. At the time of this update nine bricks have been placed, with a number of additional bricks planned for placement before winter sets in. If you haven't visited McGuire Lake for awhile, we encourage you to go, and take a few minutes to appreciate the messages, memories and people associated with each of the engraved bricks.
