

To provide a vehicle for residents of the Shuswap to enrich their community in perpetuity through the establishment of a variety of endowed funds;


To disburse the earnings on the capital funds annually to build community capacity and to support charitable projects that will enrich the lives of residents;

Message From the President

The Shuswap Community Foundation enjoyed another fantastic year in 2006-07—which promises a great future for our communities. Last year 4 major new funds were established by caring Shuswap residents, and contributions to community funds helped to push total assets to over \$1.8 million.

Directors are confident that our assets will reach the \$2 million mark sometime this year, reflecting a growing recognition by Shuswap residents of what we like to call "the foundation difference."

The Shuswap Community Foundation is "different" from other community charities and agencies in a number of ways: it is autonomous; it is entirely local; it deals only in endowed funds; it is forever—the Foundation will still be here in 50 years, in 100 years, in 1000 years, and somewhere along the way it will become the most significant non-governmental funder of quality of life initiatives in our area. But the most significant "foundation difference" is that the Foundation does not do "charity"—it does "philanthropy" by funding the good works of charities.

And the Foundation provides the vehicle for everyone, well-off and not so well off, to be a philanthropist—to demonstrate her or his "love for their fellows" and their community by contributing to a perpetual legacy for the Shuswap.



Triplex Provides Safe Housing



Jesse Beardmore, one of five residents in a new triplex on 5th St. and 5th Ave., enjoys his new quarters.

Shuswap Association for Community Living (SACL) fulfilled a long term goal to provide safe, low-cost housing for people with intellectual difficulties with the building of a triplex in Salmon Arm.

SACL purchased a derelict home at the corner of 5th

Street and 5th Avenue in Salmon Arm in the summer of 2005. The home was demolished later that year.

In December of 2005, Shuswap Construction Industry Professionals (SCIP), School District #83, Okanagan College, Salmon Arm Savings and Credit Union (SASCU) and Shuswap Association for Community Living began exploring the possibility of partnering and building a triplex.

All the partners approved the concept and construction began in the spring of 2006.

The first tenants moved in at the end of December with the last set of people moving in March

2007.

The Mary Douhaniuk Memorial Fund and General Fund provided \$5000 toward the purchase

of appliances. Each unit has a dishwasher, washer/dryer, stove, refrigerator and microwave.

The concert, directed by Aileen Gentles, saw a choir of choral singers gathered from the Shuswap and represented singers of every kind of experience from folk to jazz. The concert gave singers an opportunity to sing an original work by Gentles called The Venite as well as classical pieces.





Ken & Lillian McKee: Featured Founders

Salmon Arm resident Ken McKee is one of the Foundation founders and a strong supporter of the Foundation's philanthropic work. In an interview last year, Ken states, "I've always been a home town booster."


Ken's early working life was typical of many young people in the Great Depression. In 1942 he joined the Canadian Air Force working as an armourer. Following the WW II, he was recruited back into the Air Force winter-testing airplanes for British and Canadian forces. It was during this time he contracted polio eventually losing the use of his left arm.

After leaving the Air Force, Ken and Lillian moved first to Edson and later to Salmon Arm. Ken became a council member (1962-63) and later Reeve (1964-65) for the District of Salmon Arm. Later he worked for the Columbia Shuswap Regional District as secretary/treasurer and administrator.

Blair Borden: In Memoriam

"Some funds became available and I couldn't think of a better use for them," said retired music teacher Blair Borden commenting on her \$10,000 donation to the Shuswap District Arts Council Scholarship Endowment Fund. (*The fund is held by Shuswap Community Foundation.*)


She added, "I'd like to see the focus on music and not necessarily on youth. I think learning goes on all your life."

Blair died at age 71, October 31, 2006.

Active in the local music scene for many years, Blair played string bass in the Salmon Arm Community Band. "I was one of the seven originals," she recalled, "and at that time played the E-flat tuba." She instructed an Adult Beginner Band class through Okanagan College for a couple of years and several of her students now play in the band. Born in Toronto, Blair grew up in Montreal and attended McGill University. After graduation, she spent two years travelling and working in recreation in both London and South Africa.

She arrived in Salmon Arm in 1968 to teach school and was encouraged by then principal Tom Brighouse to move into music teaching. When she first lived in Salmon Arm she played with the Okanagan Symphony for 10 years and later, after a move to Sorrento, played for another 10 years in the Kamloops Symphony. Blair also joined the Shuswap Singers. During these years with the symphonies she played the string bass and brass instruments. "I consider myself a specialist in low brass instruments," she commented.

The Foundation is pleased that families, who have been in businesses supported by the community over the years, are now seeing an opportunity to give back to their community...and giving back in perpetuity!




The Foundation has also set up funds with the Douhaniuk, Wainwright-Mobley, and Phillips families, to name just a few, who want to remember a loved one.





A \$3,000 grant from the Askew Family Fund and the General Fund gave the Salmon Arm Bay Nature Enhancement Society (SABNES) an opportunity to make important renovations and repairs to the Interpretive Centre, located at Salmon Arm's Marine Park, early this spring.

SABNES replaced the wooden support pads and beams as required with new treated material and fixed up the floor joists that needed repairs. The skirting was replaced with new treated plywood, new venting installed in the roof system and crawl space. As well, the eave drainage system relocated to help prevent future water problems around the building.

SABNES members and volunteers took part in a spring clean up to get the centre ready for the busy year ahead.


The Society is also planning some other internal renovations to the building this year.

The Village also purchased 33 new chairs with the funds. Money for the Heritage Village Event Enhancement project came through the Monk Endowment Fund.



Family Fund Established With a Gift of Shares

"Just taking care of business"

Walter and Betty-Jean Derkaz and their daughter Cindy moved to Salmon Arm in 1958 after Walter was appointed manager of Shuswap Consumers' Co-op.

Two years later Walter and Betty-Jean made the big decision to take their few hundred dollars of savings and "go into business." Derkaz Shoes opened on Alexander Street offering "a full range of footwear for all the family." Ten years later a second store opened in Vernon.


Walter and Betty-Jean always believed that you should support those who support you. They knew that the success they enjoyed in their businesses, and Cindy's success in her law practice, was due to the loyal support of the local community.

Walter liked the concept of a community foundation because it provides a simple way to give back to the local community. Walter also liked that Shuswap Community Foundation is run by a group of dedicated volunteers with a wide range of expertise. And the Foundation does not charge administration fees against the funds under its management.

When his beloved Betty-Jean died in 1997, Walter launched the Foundation's Seniors Project Fund with a donation in her memory.

On his death in 2006, Walter left a gift to the Foundation in his Will of \$20,000 in shares to establish the Derkaz/Derby Family Endowment Fund. In keeping with his management style, Walter made the gift completely discretionary. The directors of the Foundation will be able to use the income to meet the community's needs as they change over time.

By making a gift of shares, Walter's estate was able to reduce his final income tax bill by taking advantage of the 2006 change in the tax laws eliminating capital gains tax on public traded securities that are donated to registered charities, and by using the \$20,000 charitable donation tax receipt issued by the Foundation.

SAGA Endowment Fund Now Stands at \$200,000

"Thank You, Thank You, to all Gallery members and supporters. And Thank you to the Vancouver Foundation and the BC Arts Renaissance Fund" states Gabriele Klein, Shuswap Art Gallery Association (SAGA) Fundraising Chairperson.

SAGA, its members and the community are celebrating another matching grant from the BC Arts Renaissance Fund. SAGA members have, for a second year in a row, responded generously to the Endowment Fundraising Campaign.

In the summer of 2005 the BC Government set aside \$25 Million in the BC Arts Renaissance Fund to support arts and culture organizations by providing matching funds. The Vancouver Foundation was charged with administering this fund. SAGA applied last year and received a matching grant. "Since the \$25 Million was not yet exhausted we felt we had to try again to help us on our road to financial stability and independence," Klein says.


"SAGA's Fall 2006 fundraising drive and Gallery fundraising events brought in \$30,209 - a wonderful result," says Klein. With the matching grant the SAGA Endowment Fund now stands at \$200,000.

Klein adds, "a special thank you goes to the Salmon Arm Savings and Credit Union and the Salmar Community Association for their generous support. Their assistance encourages and helps volunteers do the work that enhances the quality of life in our community."

Klein notes, "It is important to realize that this money rests with the Shuswap Community Foundation in perpetuity for the benefit of the SAGA Public Art Gallery and its work in the community. Only the interest earned may be used. Additional donations and legacies will allow this principal to grow and move SAGA along the long road to financial stability and independence."




