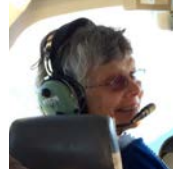

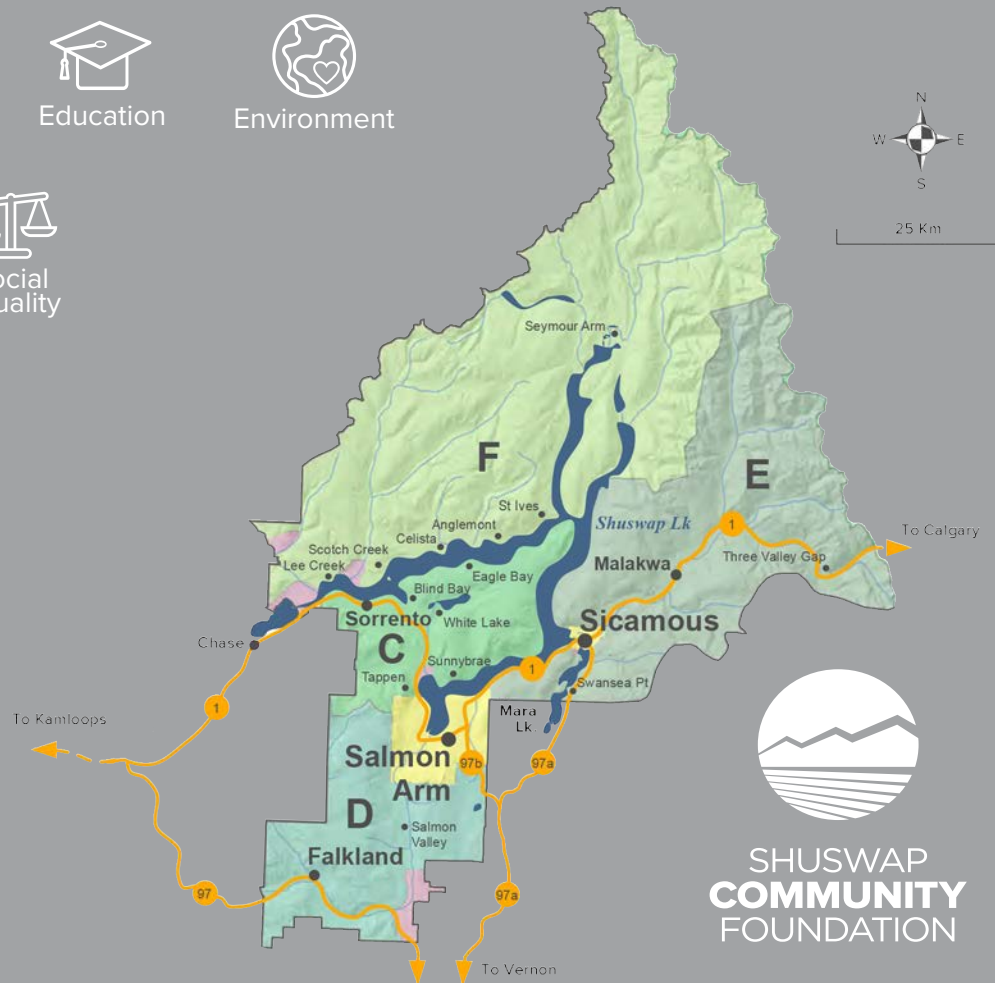

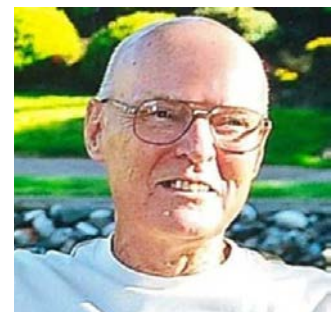

FUND NAME: Wendy & Rod Charlebois Endowment

FUND PURPOSE: Social Justice & Board Discretion

Rod and Wendy were born and raised in Montréal, Québec where they married in 1970. They lived in Ontario, then moved back to Montréal in 1976. They have three children and four grandchildren. They chose to move to Salmon Arm in 1997, having explored the area on several trips west before making the move. Both say it just felt right. Both have zero regrets.

Rod worked in various aspects of radio and television broadcasting and later as a freelance voice for commercials and corporate communications, continuing after moving to Salmon Arm. Wendy worked in banking until their children were born and later worked with seniors in Montreal. This experience stood her in good stead when she became the Manager of the Seniors Resource Centre here in Salmon Arm.

Both Wendy and Rod are enthusiastic cross-country skiers so Larch Hills was a big drawing card for them. They have enjoyed being involved with the Nordic Society. Wendy was a member of the Arts Council board and is part of a church group visiting seniors. Rod coached seniors in the use of computers

and was MC for the Shuswap Music Festival closing concert for several years. He joined a number of CBC broadcasters and other local performers for readings of "A Christmas Carol", part of a CBC fundraiser.

In 2015, Wendy and Rod decided they wanted to acknowledge the community they love and which has given them such a great quality of life. They chose to create an endowment with Shuswap Community Foundation. Their endowment supports issues of Social Justice in the Shuswap. Wendy and Rod believe all people have the right to live with dignity and they want to do what they can to foster that belief in others. They know their endowment will live on, generating income that can be disbursed annually, in perpetuity.

## FUNDED ORGANIZATION - GreenSpace at First United Church

GreenSpace is an initiative designed to bring people together to create community, promote wellness, sustainable living, and provide individuals and non-profit groups an open and welcoming space from which they can engage in the things that matter most to them.

It is founded on the premise that "united, we can accomplish great things." GreenSpace seeks to bring people together, share its space as a community resource, and to work alongside others to make the world a better place.

Our building has a long history as a base for community action and networking. We have supported, partnered with, and provided safe space to the Rainbow Café, CKVS Radio Station, Mirella Project, Access Justice, Kairos, Shuswap Solar Energy Society, Shuswap Food Action Network, Hospice, World Women, Coldest Night, Mother Goose, Canadian Mental Health Association, Grandparents Raising Grandchildren, and the SAFE Society. In addition, we support wellness programs, including groups such as AA, Tai Chi, Meditation, Yoga, and the

Labyrinth.

Providing air-conditioning to the second floor is one phase of a long-term plan to maintain and upgrade this building as a community asset.

# FUNDER PROFILE

FUND NAME: Rob Nash Memorial Endowment

FUND PURPOSE: Shuswap Trail Alliance & SCF Board Discretion

Rob Nash met Heather Bettles in his Grade 6 class at Salmon Arm West school. They married on August 27, 1994. Both always felt fortunate to be raising their two children, Andrew and Leah, in such a beautiful community.

After obtaining his Mechanical Engineering Technology diploma at B.C.I.T. Rob returned to Salmon Arm to take up a position with Newnes Machine Ltd. (now USNR) and then in 2001, started working for PQ Systems Ltd. Heather had obtained her degree in Physiotherapy and, after working at Vancouver General Hospital for two years, moved back to Salmon Arm to take up a position at Shuswap Lake General Hospital. Heather says they created a wonderfully balanced life, especially after they moved to their small acreage in South Canoe in 2011, where Rob was able to work from his small timber framed office, just across the back yard.

Rob loved exploring the outdoors with family and friends, proud to call the Shuswap home. He made many handcrafted trailhead signs, including maps, distances, and GPS coordinates. At one point, he imported a wooden troll from Norway, placing it beside his custom-made wooden sign for the famous South Canoe Troll Bridge. Rob had a passion for this sort of detail that users of the trails will enjoy for many years.

Rob's life was enriched through his volunteer activities; he lived life well and loved through his actions.

Salmon Arm and the Shuswap are the beneficiaries. "A good day for Rob was a day that he could help somebody" says Heather. "We hope that building a legacy fund in Rob's name will ensure that his passion and commitment to his community will continue to make a rich and meaningful impact for generations to come."

90% of the earnings of the fund will be disbursed to the Shuswap Trail

Alliance each year. The remaining 10% will be granted at the discretion of Shuswap Community Foundation.

The fund is open to contributions at any time.



## FUNDED PROJECT - South Canoe Shelter

The Rob Nash Memorial shelter is part of the South Canoe Parking Development Project, a series of extensive upgrades to the South Canoe Trailhead. Rob and Heather were very excited about the community/learning shelter idea. Heather approached the Shuswap Trail Alliance to see if the shelter might be built in Rob's memory, as he had given so much to Larch Hills, surrounding trails, and community over the years, and the shelter would be located a stone's throw from his family home. It was quickly and unanimously agreed by all involved.

Donations from friends and family enabled Shuswap Trail Alliance to move forward more quickly than originally anticipated.

The shelter will be located near the centre of the existing meadow and available for all to use.

## PROJECT PROFILE - RBC FUTURE LAUNCH

When YPAC received the RBC Future Launch Grant of \$30,000, we were ecstatic! We had been working together for almost a year and we had only just gone through our first grant cycle with Shuswap Community Foundation (SCF) a few months prior. YPAC reached out and advertised for youth organizations who might want to apply for the RBC grant. When it was time to analyze applications and grant the money, we had guidance from Roger Parenteau, SCF's Manager, and Paige Hilland, our SCF liaison, but the final decisions were made by us. We decided to give \$15,000 to the Mirella Project and \$15,000 to Shuswap Youth Launch. YPAC has talked to each group on multiple occasions since granting. However, when COVID restrictions were put in place both groups had to postpone their projects. The two groups rely on schools being open for youth engagement. As of now, September 2020, the Mirella Project is getting back underway and Shuswap Youth Launch is going to be held in early 2021. It will be a virtual event. As part of receiving the RBC Future Launch Grant, YPAC was to hold an event that discusses youth's needs and wants within the community. Initially we were to have in-person conversations, but

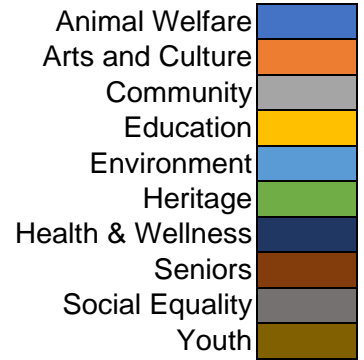

Youth funds are open to contributions at any time.

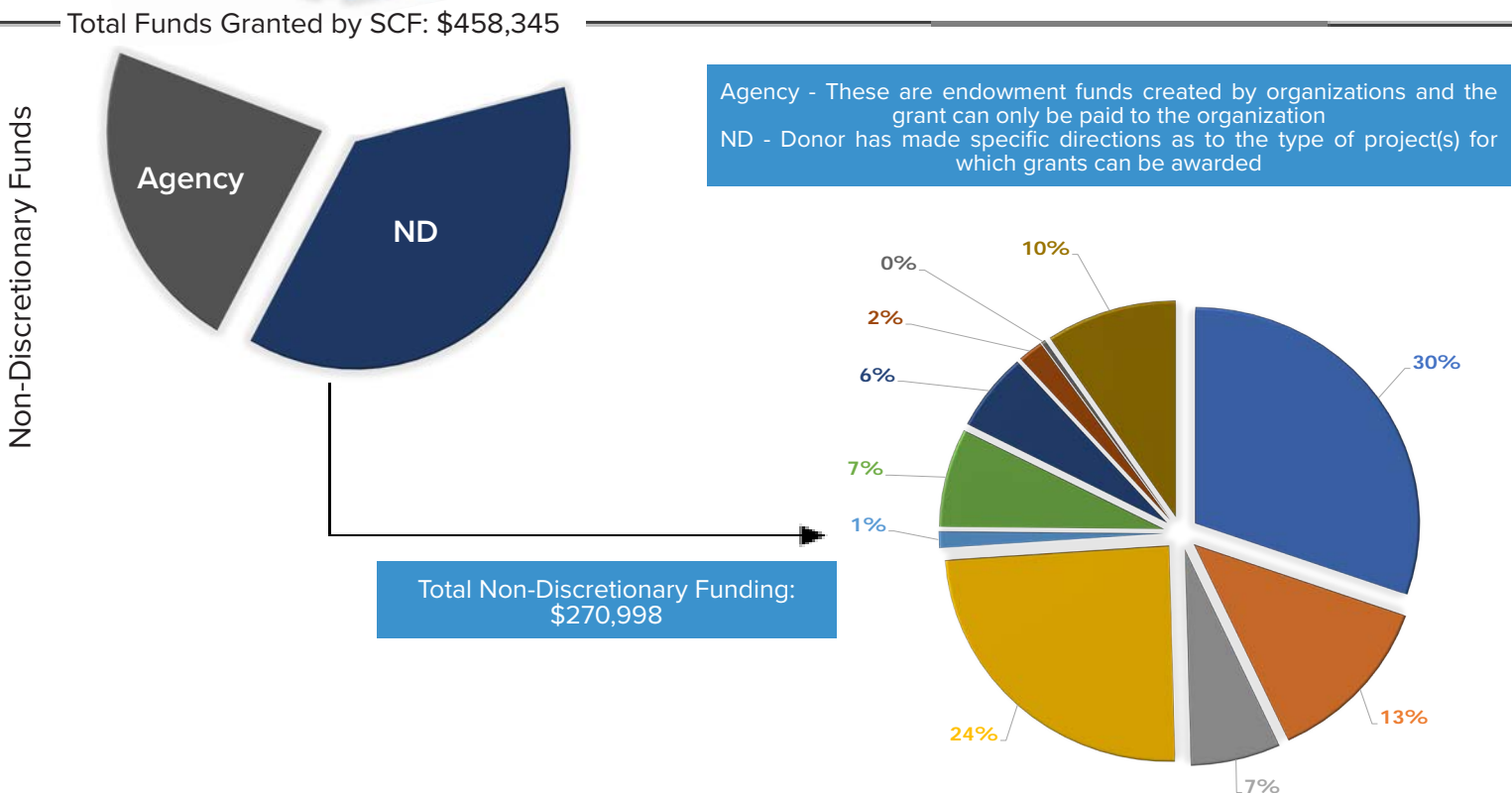
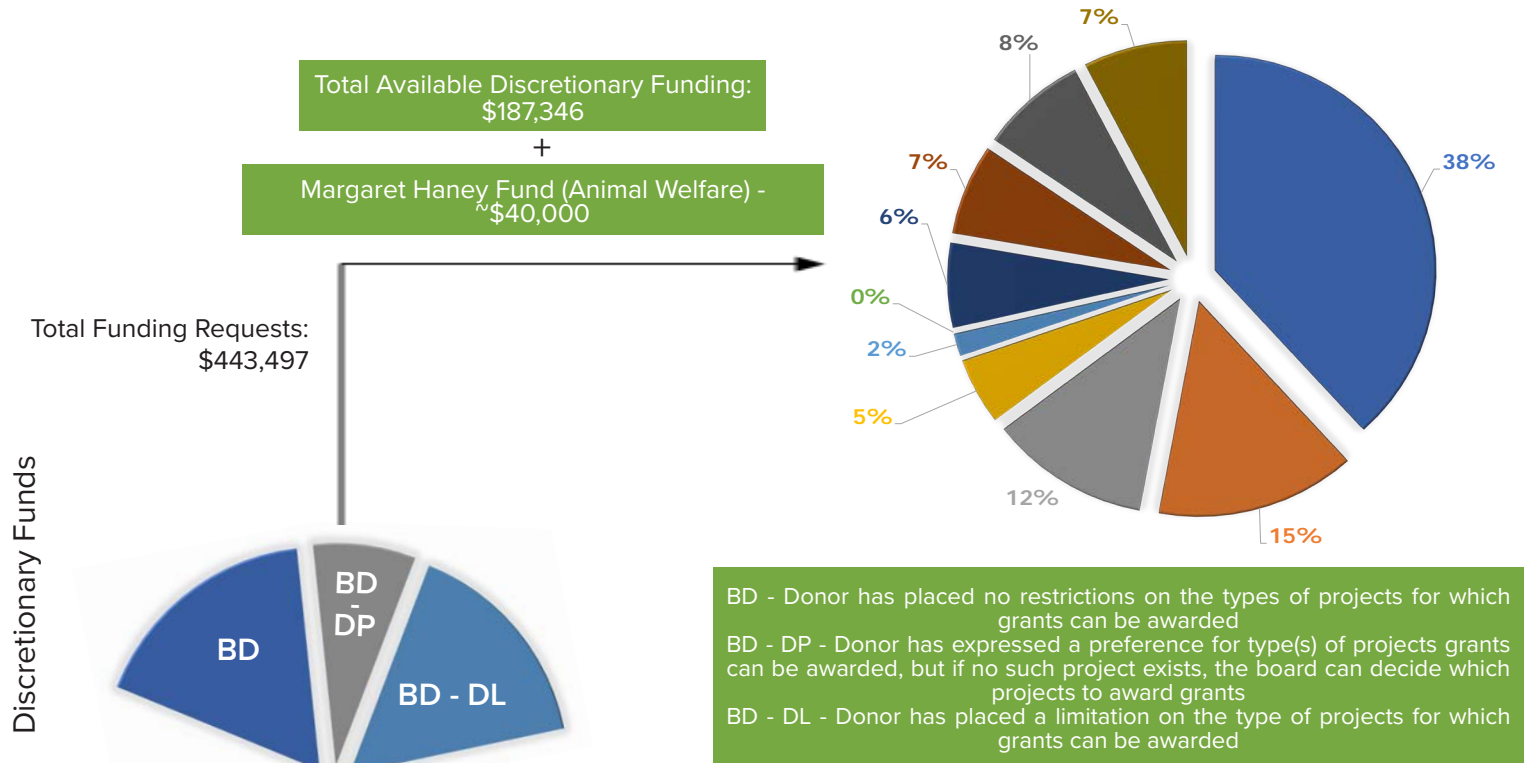

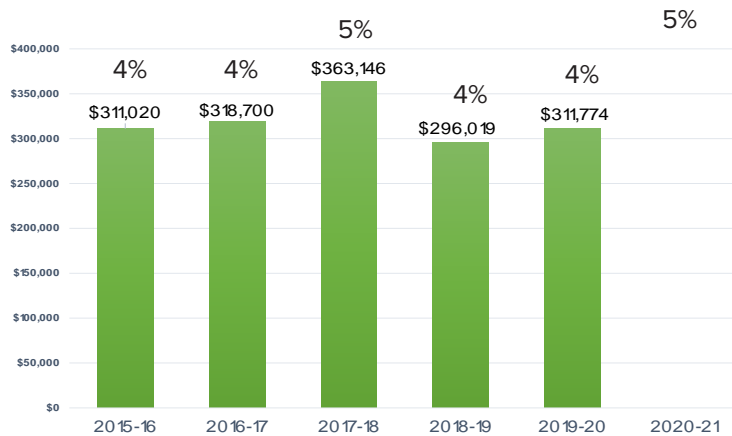


## BREAKDOWN OF SCF FUND DISTRIBUTION

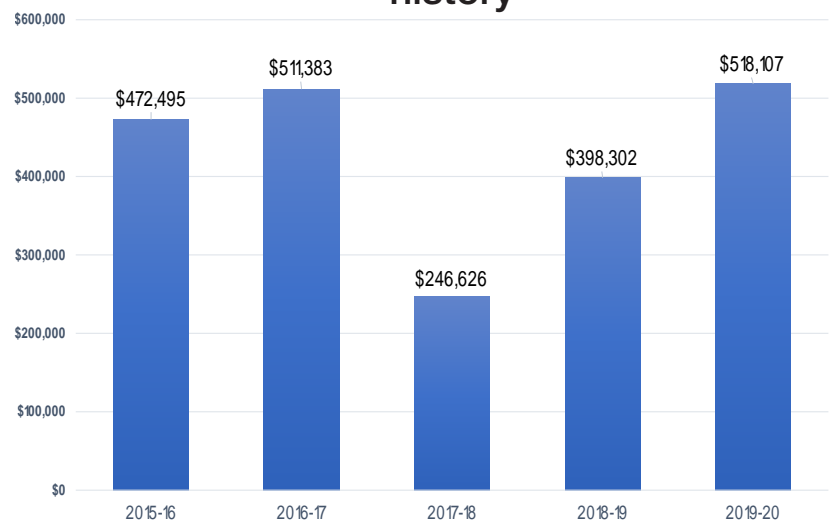




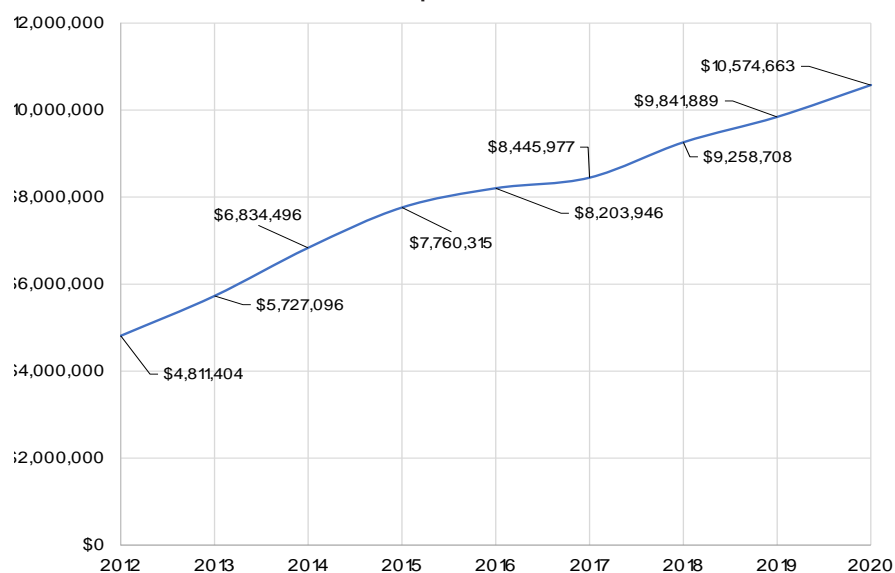
## SCF Grant Disbursements By percentage and \$ amount

# FUNDER PROFILE

FUND NAME: Ian and Wendy Clay Endowment

FUND PURPOSE: Board Discretion - Donor Limitation

Ian and Wendy Clay lived, worked, and 'played' in Salmon Arm and area for 30 years where they were loyal and hard-working volunteers whose legacy lives on. Both grew up in Victoria, and always planned to return after retirement, so moved back in 2017.

Ian worked with the BC Forest Service (1987 to 2011) as a Forest Technician, first in Salmon Arm, then in Vernon. Wendy taught school. In 1990 she went to work with Sally Scales on the Shoppers' Guide community newspaper. When Black Press took over she became the Editor of the Lakeshore News, retiring in 2011.

In the early 90's Ian helped build a trail network at Little Mountain Park. Then he worked on trail development in Coyote Park, Cress Creek Trail and Park Hill. These permanent trails can be enjoyed by everyone – now and in the future. Ian feels trail building provided his greatest personal satisfaction in giving back to the community.

Both volunteered at Larch Hill. They were members of Shuswap Outdoors and have wonderful memories of hikes in the Monashees, Roger's Pass, and the

Rockies.

Travel is their other great passion. Europe, Southeast Asia, Turkey and East Africa were visited, as well as almost all of Canada. Members of the Shuswap Photo Arts Club, they feel that photography opened their eyes to seeing the natural world, and that something new and exciting was already around the next corner. With the establishment of their fund, they are giving back to the community that provided them with a rich life and many friends. They want others to experience what they enjoy(ed) by supporting various causes in their fields of interest. Their fund will support, in perpetuity, their passion for the outdoors and the Shuswap community.

There are more than 5,200 Special Olympics athletes in 55 communities throughout B.C. FUND NAME: Karen Angove Endowment

FUND PURPOSE: Donor Directed & Board Discretion (Split)

Born and raised in Salmon Arm, Karen Askew Angove learned about work and responsibility at an early age. She graduated from Salmon Arm Secondary and worked at Askew's in the summers. She remembers when her parents, Lloyd and Dorothy Askew, ran Salmon Arm Meat and Produce Limited on Alexander Street. Then in 1968, when she was in Grade 11, they built the store on Lakeshore Drive.

In 1988 Lloyd started thinking of retirement and approached Karen to take over the business. Her brother and older sister lived their lives in Vancouver and showed no interest in the business. Karen took up the challenge, retiring from Forestry, and plunging into a steep learning curve with Lloyd and Dorothy as mentors in the grocery business.

"It was incredibly hard work—managing the stores, planning for the future of Askew's, being a mother and wife." And, she was involved in community organizations. Working at Askew's, Karen demonstrated what it means to be progressive, open minded, and inclusive. Her employees and the community respected her.

Lloyd had opened the Armstrong store in 1975 and Karen continued to expand, opening the Sicamous store in 1997. In a visionary move she purchased the uptown property in 2006. With the property in place,

the uptown store was built in 2012.

Karen managed Askew's from 1988 until 2009, a total of 21 years.

Karen's long years of community involvement in both the business and volunteer sectors gave her a good feel for community needs. In 2019 she established

the Karen Angove Endowment Fund to satisfy two of her passions—the SAFE Society and the needs of the Foundation. Karen has designated 25% of the proceeds from her fund for the SAFE society. 75% will be disbursed at the Foundation's discretion. While many funds support specific worthy causes, Karen knows that Foundation directors need flexibility to meet evolving community needs. Karen's vision will help fill this need in perpetuity.

## FUNDED PROJECT - The Shuswap Area Family Emergency Society (SAFE)

The Shuswap Area Family Emergency Society (SAFE) was established in 1979 as a grassroots organization by a group of community members who recognized the need for a safe haven for women experiencing violence in the home. The Society's mission is "to End Violence in the Shuswap."

The SAFE Society's purpose is to provide transitional shelter and housing, counselling support, information, and education to persons who have experienced abuse in their intimate relationships, criminal harassment, sexual assault or other crisis situations, as well as to create and present public education and awareness programs designed to promote the prevention of violence in the Shuswap.

We serve a large geographic area including Salmon Arm, Sicamous, Malakwa, Enderby, Silver Creek, the South and North Shuswap, to Sorrento and Chase. Services are provided 24 hours per day, 365 days per year.

Through the support of the Shuswap Community Foundation and its many generous donors the SAFE Society has been able to undertake several exciting projects in the last few years including:

- Upgrades for our children's group room
- Appliance upgrades for the Transition House kitchen
- Support for increased access to technology for clients and program staff during the COVID-19 pandemic with a grant from the federal Emergency Community Support Fund.

# AGENCY FUNDER PROFILE

FUND NAME: Sorrento and Area Community Health Centre

With the engagement of a Nurse Practitioner (NP), the Health Centre began providing primary care to the residents of our communities on November 18, 2013. The Centre was equipped through the generous donations of many organizations and individuals, including Shuswap Community Foundation (SCF).

The Centre offers primary care provided by Theresa Walters, NP. Foot care and immunization clinics are also held, and a walk-in clinic during the summer is provided by a locum physician. Our service area is primarily the communities of the South Shuswap. Our patient roster stands at approximately 1000, which is the maximum our NP can manage. As demand for service is more than we can supply, the Society continues to pursue opportunities to increase its patient roster by adding another NP or a General Practitioner to the centre's staff.

Our patients are ecstatic to be able to access care locally, avoiding the commute along the Trans Canada to seek medical attention. Our Nurse Practitioner, with a broad scope of practice, provides exceptional care with the ability to diagnose, order diagnostic tests, order prescriptions, and make specialist referrals.

SCF has an important role in the continuing operation of the Centre. The Directors of the Health Centre Society foresaw a need to provide for long term funding, so an endowment fund, The Sorrento Health

Centre Endowment, was established to provide operational and capital funding for generations to come.

All donations and bequests added to the fund allow for a greater distribution each year.



## FUNDED PROJECT -

Our project for 2019 was to provide a walk-in clinic, at the Health Centre, staffed by a locum doctor, for our summer visitors. It ran for most of July and August. With a few modifications because of COVID it was a success again this year. This is a program we will be pursuing each summer now.

Regarding our support of the South Shuswap Transportation Society, many health reports show transportation to medical appointments is an issue in terms of access (having a vehicle) and cost. From our Health Centre's perspective, we believe this is a service which some of our patients will be able to use whether it be for medical appointments at the Health Centre or other locations for specialists, or other shopping which is necessary for positive health outcomes.



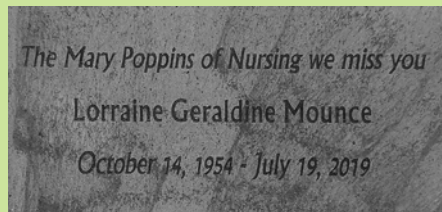
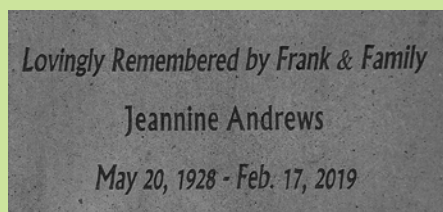
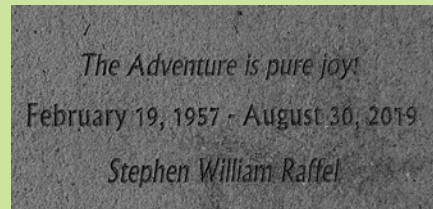
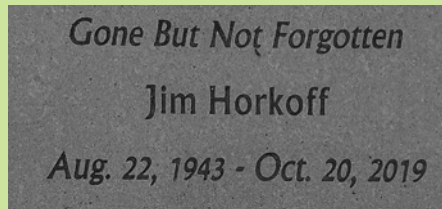
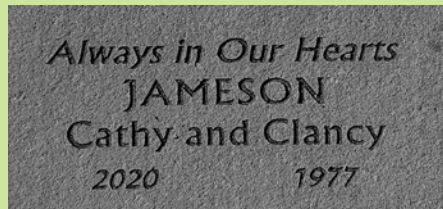
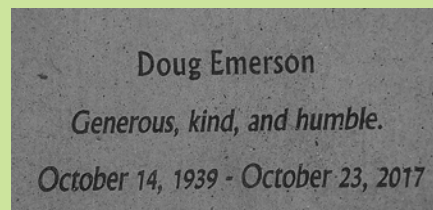
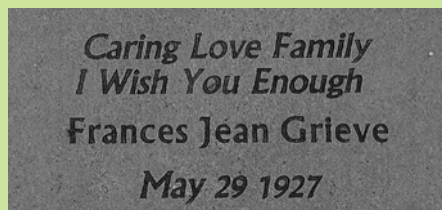

## FUNDED PROJECT - RESPONSIVE NEIGHBOURHOOD SMALL GRANTS (R-NSG)

In early March Shuswap Community Foundation

announced the Neighbourhood Small Grants (NSG) program in partnership with Vancouver Foundation. The NSG program was created to help build community and strengthen connections right where people live – in their

neighbourhoods. The program supports community members with small but powerful ideas to bring people together and make neighbourhoods vibrant.

By mid-March, the COVID-19 crisis brought unprecedented change to our daily lives.

While physically distancing, sheltering in place & social bubbles have helped flatten-the-curve of the virus' spread, it also resulted in increased social isolation in our communities.

Working quickly with our partners, SCF was able to relaunch as the Responsive Neighbourhood Small Grants (R-NSG) program.

This new program is intended to fund small-scale projects that reduce social isolation and invites individuals to dream up creative projects that address the following areas: decreasing social isolation; building community strength and resilience; and fostering community creativity and wellbeing.

The R-NSG provides grants of up to \$350 for projects

that connect people socially or involve sharing skills or talents with each other.

The program saw a rapid uptake in communities across the Shuswap, with SCF receiving more than 40 funding requests. Projects ranged from Zoom Yoga classes, Art boxes for youth to care package drop-offs for the homeless and seniors.

Now more than ever, residents of the Shuswap need to stay connected with their neighbours and other community members. In doing so, we will maintain community resiliency and ensure a more rapid recovery.

We will continue to use Responsive Neighbourhood Small Grants to strengthen community bonds and to keep us all connected.

## FUNDED PROJECTS - The Shuswap Makerspace - Sound Studio

In addition to providing funding to the Royal Canadian Air Cadet Squadron #222 and the Shuswap Area Family Emergency (S.A.F.E.) Society, the SCF Founders Fund also supported a joint application by the Salmon Arm Economic Development Society and the Shuswap Family Resource Centre.

The Shuswap Makerspace is located on the ground floor of the Salmon Arm Innovation Centre Powered by SASCUC. The Makerspace is a community space designed to spark interest in technology, innovation and creativity. Currently home to virtual reality, 3D printing and a complete woodshop, we are excited to be adding a sound studio to our list of offerings!

With financial support from the Shuswap Community Foundation, and through a partnership with the Shuswap Family Resource Centre, the new sound studio will be launching to the public in late 2020. A vacant room in the Makerspace has been repurposed and retrofitted with sound dampening assets, recording equipment, and software, creating a space that will be ideal for recording podcasts and music. Going forward, the Makerspace will also be offering recording workshops for all ages. We are very grateful for the grant from the Shuswap Community Foundation, which supported the costs of equipment purchases and enabled this project to move forward!

FUND NAME: Hana & Glen Larson Family Endowment & Hana & Glen Larson Endowment

RECIPIENTS: School District No. 83, North Okanagan-Shuswap & School District No. 58, Nicola-Similkameen

Glen and Hana Larson were married for 59 years. They met in 1954 when he was helping Hana's brother spray strawberries on the Tanamura family farm here in Salmon Arm. They had two children, Jill and Spencer, both deceased.

In 1946 the Larson family moved to BC, eventually settling on a five-acre property in South Canoe in 1951. Glen graduated from Salmon Arm Consolidated High School in 1952, and in 1956 went to Technical School in Montreal, achieving a First-Class Radio Operator Certificate, as well as training in Meteorology, Electronic Design and Repair, and Civil Engineering. Hana obtained her teaching certificate at Normal School in Victoria. They were wed on August 1, 1959.

Working for the federal government meant Glen and the family lived in various places throughout BC, moving to Princeton in 1968. Hana resumed teaching and they bought a 52-acre farm. The eight years they lived in Princeton held a special place in the hearts of the Larson family.

Glen's final position was as a Technical Consultant for the Radar Modernization Program (RAMP) in the Vancouver regional office of Transport Canada. He retired in 1989, and he and Hana came back to the Shuswap, settling in Salmon Arm in 2012. Sadly, Hana died in November of 2018.



Glen and Hana greatly valued education, so in 2018 the Larson Family Endowment was established in memory of Hana, Jill, and Spencer. It will provide a bursary to School District No. 58, Nicola-Similkameen. In March of 2020 Glen established the Hana and Glen Larson Endowment, which will provide a bursary to School District No. 83, North Okanagan-Shuswap. The bursaries provided by the funds will be awarded to a student in each district who intends to pursue further academic or vocational education, is of good character, has demonstrated community involvement, citizenship, and leadership, and is in need of financial assistance.

# COVID-19 RESPONSE

In late April, the federal government announced a \$350 million Community Emergency Response Fund (ECSF) to support charities adapting their frontline services to support vulnerable Canadians during the COVID-19 pandemic.

Through this program Shuswap Community Foundation (SCF) was allocated \$75,000 of funding to help fill gaps and address long term and emerging needs in our community. SCF worked quickly to launch a call for grant applications and receiving a total of 14, with funding requests totalling \$191,000. The applications were reviewed by SCF's volunteer grants review team on an ongoing basis through June and July. Funds were distributed through July.

"These last six months have shown us that SCF, along with its many donors and fundholders can rise to the challenges our community is facing," says SCF Manager, Roger Parenteau. "It's inspiring to work in partnership with so many local community groups and charities, to respond as needs arise, and pool our expertise to meet those needs and protect our most vulnerable populations."

Some notable grants include nearly \$20,000 to support the continued operation of Community Halls and Associations through the North and South Shuswap, and a grant of \$10,000 to Shuswap Food Action Society to help build regional and household food security in the Shuswap.

## EMERGENCY RESPONSE GRANTS

Through a generous partnership with the Vancouver Foundation in April, Shuswap Community Foundation (SCF) recently launched the Emergency Response Grants (ERG) program. These grants are intended to offer assistance on a one-time basis to charities and not-for-profit organizations located within the Shuswap region. These selective, modest grants are based on critical need. The Emergency Response Grants allows us to quickly direct funds to support charities, non-profit organizations, health authorities, and emergency service providers serving those affected in the Shuswap by the COVID-19 pandemic and other crises. Key priorities are programs or projects that focus on keeping Shuswap residents safe, healthy, fed, sheltered, and connected, especially residents who are vulnerable or have financial need.

### PROGRAM PRIORITIES

The Emergency Response assists charities/not-for-profits with a short-term urgent funding need, for which no other resources are immediately available, created by an unforeseen event(s) that has or will significantly interrupt their essential services.

### ELIGIBILITY

Requests may be submitted at any time by charities/not-for-profits located in and serving residents of the Shuswap. Generally, Emergency Response Grants are intended to address an urgent and immediate need;

- a need for which no other resources are immediately available;
- an emergency situation; or
- an unanticipated or one-time need.
