### **President's Report**

#### 2010/2011 Fiscal Year



In this report we highlight stories of a few of our many founders, donors and charitable organizations. Their stories demonstrate what the Foundation is really all about. It is what makes the task of leading the Shuswap Community Foundation so rewarding.

As the years go by our organization is maturing. The Foundation is here in perpetuity but alas, our directors are not. It is therefore important that our stewardship of endowment funds is done in such a way as to allow a seamless continuation year after year. This year the investment committee has taken a good hard look at the way we are managing our investments. On the committee's recommendation, the decision has been made by the Board to hire an investment management firm to manage our funds. We have done very well up to this point - in fact better than many foundations - and we are extremely grateful to our local investment advisors from Scotia McLeod and RBC Dominion Securities for our success. With the challenges in the marketplace and with our funds growing we have decided that this move will be a more efficient way to manage our endowment funds and allow our directors more time to focus on growing our funds.

A very significant event for the Foundation this year was the retirement of our President, Cindy Derkaz at the end of January. Cindy was involved in initially setting up the Foundation and has been on the Board ever since. She was president for a total of 11 years, participating on every committee. She is passionate about the organization. This, and her attention to detail and work ethic, has set a high standard for the organization. She has left us in good shape with a very capable board. From the bottom of our hearts, we thank her for her contribution and wish her all the best. To take her place on the Board we have welcomed back Gary Brooke, another charter member of the organization.

Two more directors are retiring this year, Marilyn Brown and Ted Apted. We thank them both for their hard work and dedication and will miss them around the board table. We welcome two new directors, Rod Bailey (Sicamous) and Melany Dyer (Sorrento).

The Foundation continues to grow, with our endowment fund reaching \$4.6 million this year. We will be handing out \$158,852 in grants to the community at our Annual Community Meeting this year. Of special note this year is the first grant disbursed from the Browne Johnson Legacy Fund established in 2007. Their business celebrates its 50th anniversary this year. They set up this fund of \$50,000 so that each year a grant will be given in the firm's name to show their appreciation of the support the community has given them throughout the 50 years.

Four of our directors and our administrative assistant, Laurie Ankenman, attended the Community Foundations of Canada conference this spring. The conference gave us the opportunity to network with other foundations from Canada and around the world, to listen to many philanthropic speakers including Bill Clinton, Naomi Tutu, and Governor General David Johnson, and to attend many workshops that made this a very significant and worthwhile experience.

On behalf of the board, I would like to thank all our donors and sponsors for their continued support. I personally thank the board for their support during this transition time while I take on the daunting task of replacing Cindy at the helm of this wonderful organization. Together, we will grow and build for the future of our communities.

# **Browne Johnson Land Surveyors**

The plan took shape early in 2007. In 2011 Browne Johnson Surveyors would be 50 years old, and the partners wanted to commemorate this milestone by somehow sharing the results of their success.

Bob Browne, Greg Browne, Joe Johnson and Brian Sansom believe they have a duty and responsibility to give back to the community that has sustained them since 1961, so they decided to create an endowment fund with Shuswap Community Foundation.

It all began in March of 1961, when M.D. (Bob) Browne moved his family to Salmon Arm and opened up a land surveying business. As the business grew, several moves were undertaken to accommodate more employees and equipment. The office is now located on Alexander Street in Salmon Arm, where they 'feel part of the downtown community' says Joe Johnson.

In 1988 Greg and Joe joined forces, purchasing the business, together with land and buildings, and renamed it Browne Johnson Land Surveyors. The company has worked all over the Shuswap and various areas of BC, as well as in national parks and aboriginal lands across BC. It credits its success to all those dedicated individuals who have made up the team at Browne Johnson, past and present.

Now the plan has reached fruition. The first grant from the Browne Johnson Legacy Fund established in 2007 will be disbursed at the discretion of the directors of the Foundation in October 2011. A grant will continue to be given in the firm's name in perpetuity, each year extending a thank you to the Shuswap community for its support of the business.

### Ted and Wendy Apted, **Foundation Founders**

In 1968, Ted & Wendy Apted moved to Sorrento, BC. Ted, holding a M.ED in Psychology, was a special counsellor in the Kamloops School District then, and commuted to work, while Wendy chose to forego a career in nursing to stay home and raise their four children, Anita, Lake, Zoë and TJ.

Ted met Wendy Finn on the beach in English Bay, where he moonlighted as a lifeguard, in July of 1956. They "clicked", and were married on December 26 the same year. After a one and a half year "honeymoon" in Ocean Falls, and the birth of their first child, they returned to Vancouver so Ted could begin working on his master's degree. From there, another move took them to Kamloops, where the rest of the children were born, before settling into the lake house at Sorrento. Wendy's parents, Eric and Enid Finn, had also moved to the Sorrento area

from Kamloops, providing grandparent support to the young family.

Ted's teaching/counselling career encompassed stints as Vice-Principal at Jackson Jr. Secondary in Salmon Arm, Principal at Enderby Jr. Secondary, and the role of Teacher in Prince Rupert, before returning to the Kamloops School District for a further 20 years. He retired in December of 1993.

Wendy's mother, Enid, was very active in the Sorrento volunteer community, and had been the Anglican minister there. Her example inspired Ted



& Wendy, and their children, to contribute and give back to their community as well. In 1994, when Ted saw an article in the paper describing the formation of Shuswap Community Foundation, and recognized the names of people he knew and trusted who were contributing funds to get the idea off the ground, he and Wendy chose to support the effort and became Founders as well.

In 2007, Ted joined the Board of Directors of the foundation he and Wendy helped establish.

#### **Shuswap Hospice Society**

A strong, volunteer-based community organization, the Shuswap Hospice Society has been offering compassionate care for the dying and bereaved in and around the Shuswap for 25 years.

Included in its services are: grief counselling, palliative care, care for caregivers, holiday support, a parents bereavement support group, a young widows' support group, a men's support group, and compassionate care for the terminally ill, to name a few.

The course, "Introduction to Palliative Care", provides 30 hours of BC Hospice Palliative Care Association standardized hospice training. The core curriculum of the course is often customized to meet the needs of the people attending, such as specific areas of concern, or the average age of the group. It is offered one or two times a year,



depending on demand. Everyone is welcome to attend, whether to become a volunteer or for personal reasons.

In 2010, Shuswap Community Foundation awarded a \$1,000 grant drawn from the Seniors Project Fund to offset the cost of providing volunteer training.

# **Brad Jackson Scholarship Fund**

He was a kind, gentle kid who loved sports. He played hockey from a young age, began playing rugby when he was in Grade 8, and had just started playing football. A fit, focused athlete, when he wasn't on the ice or on the field, he'd be in the gym, training.

Born in Salmon Arm, Brad Jackson was in Grade 11 when he passed away.

Well-liked and respected by his teachers, Brad, a straight 'A' student, set very high goals for himself, always challenging himself physically and intellectually. He told his family he might like to enter the field of medicine, or become a teacher, specifically of history, which he loved. He enjoyed school and was an attentive student who didn't give his teachers, or his parents, any trouble. His Principal, Greg Kitchen, says Brad was an exceptional student with a great sense of humour. Richard Sweet, Brad's fitness trainer, called him "the

real deal, a role model for his fellow students. He walked and talked with confidence, and treated everyone he met with respect and kindness." "Everybody loved Brad" is a frequent comment made in the memorial books his family treasures.

The Brad Jackson Scholarship will be awarded each year, in remembrance of Brad, to a graduating student who intends to pursue post secondary studies, has demonstrated combined achievement in academics and athletics, and who best exhibits Brad's qualities of self-discipline, sportsmanship and determination.

## Malakwa Community Centre Association

The Malakwa Community Centre Association is determined to maintain Malakwa as a vibrant, close knit community, whose citizens have access to all the basic services and recreational opportunities available in any community, while at the same time enjoying a rural lifestyle. To that end, the association has been instrumental in reviving the Community Park, located on Malakwa Station Road close to the old 'downtown core' of Malakwa. It borders the Eagle River and is within walking distance of the old community hall.

The park, owned jointly by the association and the (Malakwa) Farmers' Institute, is undergoing rejuvenation. Power has been installed, and a well drilled. In 2010, with the help of a \$6,000 grant from the Shuswap Community Foundation, a pump house was built and the well connected. The grant, the largest awarded to date, consisted of monies drawn from the John and Ingrid Monk Endowment Fund, the Lloyd and Dorothy Askew Family Endowment Fund, and the General Fund held by the Foundation.



This is the reason Elsie and Tom Brighouse opened a family fund in their names, from which the proceeds will begin to be distributed at the Foundation's discretion during their lifetimes.

They met at the University of Liverpool while attending teacher's college, and in 1956 embarked on the adventure of their lives by coming to Canada as young teachers, along with Elsie's daughter Pat from her first marriage (her husband drowned during an Army exercise). The province of BC sent an interviewer to Liverpool and recruited the young couple for teaching positions in Salmon Arm: Tom taught French and Elsie English at the Jackson High School. Elsie added a Masters in counseling to her qualifications and later worked in that field. Tom advanced to become a school principal and later Director of Education.

They recall the crossing by sea on the Empress of Scotland; the exciting train ride across Canada; and lovingly remember their greeting by Clara Johnston with a tea reception. In time, two daughters, Ruth and Jean, were born. They had satisfying teaching careers and enjoyed tennis, x-country skiing, hiking, camping, RVing, birding, trail building and, of course music.

Both Tom and Elsie are so proud to have been a part of the establishment of the Shuswap Community Foundation. They wanted to start their family fund while they were still alive so they could enjoy that wonderful feeling at the annual community meeting when money from their discretionary fund is handed out to volunteer groups to benefit the community. They have opened their fund to other donations.







### **Responsibility for Nature**

#### Robin Jackson Environment Fund

Robin Jackson firmly believed that people need access to nature, and that children and teenagers should be introduced to the beauty of the natural world and taught to appreciate its immense value.

A long-term thinker who favoured initiatives that would pay off over time, Robin felt that as individuals we need to reduce our personal and consumer impact on the earth, and to develop a more responsible, sustainable lifestyle. With this thought in mind, his friends and family set up this fund in the hope that his work will be carried on.

Robin was a respected economist/lawyer who chose to come to the Shuswap area in the early 1980's. Here he quickly became a partner in the firm of Brooke Jackson Downs. He did not specialize but took on criminal, family law and

general litigation cases and was a member of the West Coast Environmental Law Group. He loved the arts and participated in all that this area and its surroundings had to offer.

Ecology fascinated Robin and he understood the importance of keeping entire ecosystems, including wildlife corridors and watersheds, intact. As a dedicated environmentalist he believed that real change started with personal action and local projects. Others will carry his convictions forward through this fund established in his honour with the Shuswap Community Foundation.



## Derkaz/Derby Family

A generous grant from the Derkaz/ Derby Family Endowment Fund and the Foundation's General Fund enabled the purchase of a third rescue toboggan. Strategically located on the trail network, each about 7 km. apart, the Larch Hills Nordic Society now has a complete safety program for the Larch Hills ski area.



## 222 Shuswap Air Cadet Squadron

Cadets Cody St. Onge and Jackson Calvert attended 222 Shuswap Air Cadet Squadron's weekly ground school last fall. A grant drawn from the Wainwright-Mobley Memorial Fund, the SASCU Youth Endowment Fund, and Youth Endowment enabled the squadron to purchase a classroom set of textbooks, two computers, and flight simulator equipment to enhance the regular cadet training. Also purchased were materials for the Duke of Edinburgh Award Program, which is open to all cadets.



## Learning for Life Workshop Series

A series of free workshops was held from April 4 to 8, 2011 at the Downtown Activity Centre in Salmon Arm to celebrate International Adult Learners' Week (IALW). The Literacy Alliance of the Shuswap Society (LASS) organized this free workshop series for adults of all ages with the help of a generous grant from the Ev Painter Endowment Fund and the General Fund.
