Message From The President

The 2007-2008 year has been truly remarkable for Shuswap Community Foundation. When the fiscal year began on July 1, 2007, the Foundation's permanent capital fund was just over \$1.8 million and the directors were confident that it would reach the \$2 million mark over the next 12 months.

This benchmark was achieved in November when the Sorrento Lions Club established the Catherine Dilworth Memorial Endowment Fund with a contribution of over \$75,000. Then in December the Foundation received its largest single donation to date: a gift from the estate of Elisabeth Thomi pushed the Foundation's capital fund over \$3 million.

But this is just part of the story. The Foundation also received numerous gifts, large and small, from donors to start or build family endowment funds, remember a loved one, support a philanthropic passion, build sustaining funds for charitable organizations and to "just" give something back to the community.

Along with unprecedented fiscal growth, the Foundation experienced a change in leadership this year. Our president, Clyde Tucker, stepped down during the year after serving on the board and executive since the Foundation's inception. He will be leaving the board when his term expires in the fall of 2008. Without any doubt, much of the Foundation's success can be attributed to Clyde's dedication and vision. We will miss his guidance but he has left a strong board and organization to carry the Foundation into the future. Thank you, Clyde.

I also want to thank all our donors, corporate sponsors, board members and volunteers for their financial support and efforts. We are fortunate to live in such a generous community.

I hope you will enjoy reading the stories of our donors and our grant recipients in this year's annual report. And please let us know what you think of the report and the Foundation's activities. We want to hear from the community we serve.

Local Daycare Goes Ahead with Expansion Plans

An exciting time for children, their parents and staff at Shuswap Day Care in Salmon Arm. A \$5,000 grant from the Jennifer Phillips Memorial Fund and the General Fund combined with a number of other donations has allowed the Shuswap Day Care Society to go ahead with its plans for expansion. The daycare serves some 75 to 80 families.

Jennifer's parents, Bill and Alice Phillips, were on hand June 5th to view the expansion blueprints along with society president Kari Wilkinson, staff and many little "hard-hatted" children.

For the Phillips it was an afternoon of remembering when both of their children, Jennifer and Matt, attended this very facility in 1974/75 just after the current site opened.

The new facility will provide 40 additional spaces for children. The \$200,000+ price tag includes the property, modular building, fencing and utilities.

Ms. Wilkinson says the society is "very fortunate

and thankful for the support so that we can expand without a huge additional debt and can keep costs affordable for parents."

Daycare program director Karen Bubola, says the 24 by 50 ft. modular unit is being built in Kelowna and should be in place, next door to the present building, by fall 2008.

Other support included the Province of BC (\$105,000), Vancouver Foundation (\$25,000), two Salmon Arm Rotary clubs (Daybreak and Noon-hour - \$20,000), Salmar Community Association (\$2,500), BC Lotteries, Askew's Foods, Bill's Bottle Depot and fundraisers put on by parents.

Take nine local kids add a generous measure of four mentors and a film producer/ director, mix in support from four sources, add a big dash of winning music festival and what do you get?

A "fascinating documentary featuring an up-close, behind-the-scenes chronicle of the 15th Annual Roots and Blues Festival as seen through the lens of nine student filmmakers," according to the advertising leading up to the video's premiere at the Salmar Classic Theatre in Salmon Arm.

This venture into filmmaking was the brainchild of David Gonella, volunteer coordinator at the Salmon Arm Roots & Blues Festival. With a background in film production and direction, Gonella wanted to see young people write, produce and edit a 45-minute film focused on volunteerism at the 15th Annual Roots & Blues Festival. Starting in April 2007, Gonella invited local music teacher Brook Roberts on board to select students for this challenge. Gonella says, "We wanted to shake it up and offer a chance for the students to learn the technical side of the television and film industry."

The nine students: Hannah Gomme, Chris Petterson, Robyn Sawchyn, Dena Alexcee-Hughes,


Rory Cleveland, Pascal Gysi, Joey Meraw, Matt Ram and Kara Ritchie logged 33 hours of footage and had to edit this down to a 45 minute video.

The students were initiated into the filmmaking world with hands-on workshops, followed by the actual filming, downloading this onto a high gig hard-drive before the time-consuming editing process began with the added creative work of sound mixing and titles.

Mentors included: Brook Roberts, Andrew Meerza, and Fred Bird plus David Bercovici from the lower mainland.

Financial support came from: Shuswap Community Foundation, School District #83, Mediability and the Salmon Arm Folk Music Society.

A \$2,500 grant from Shuswap Community Foundation came from the Salmon Arm Savings and Credit Union Youth Endowment Fund and the Youth and General Funds.





Hearty Lunches

A \$2,000 grant from Derkaz/Derby Family Endowment Fund and General fund allowed the Salmon Arm & District Branch of CMHA to purchase a new oven and refrigerator for the branch's kitchen in downtown Salmon Arm.

Lee says all lunch meals are planned and prepared in their kitchen and they also teach people the basics of healthy and economical cooking. Around eight or nine people arrive each day for lunch, although they sometimes serve up to 15 people. Cost is affordable at \$2.50. Cookies and coffee are also available at a reasonable price on the lower floor of CMHA.

Wheels to Meals Warms Seniors

A hot meal on a cold winter's day is a welcoming occasion and, for seniors in Sicamous, the Wheels to Meals program at the Haven is a popular meeting place year 'round.

Operating under the aegis of Eagle Valley Senior Citizens Housing Society, the Wheels to Meals program provides nutritious lunches every Tuesday and Thursday for some 60 people. Meals are also delivered to housebound seniors.

The purchase of 15 new tables, plus upgrades to kitchen shelving and refitting the serving area was made possible through a Shuswap Community Foundation grant of \$3,400 provided by the C. Norman Barber Fund and the Seniors Project Fund.

Foundation directors had the pleasure of dropping in during a luncheon this spring. Clyde Tucker, past president of the Foundation, commented on the wonderful changes to the facilities and added that it was a treat for directors to see how the grant money has been put to use.

Engaging Families in Visual Arts



The Shuswap Art Gallery Association (SAGA) is always trying to find new ways to engage families in the visual arts. A \$1,270 grant from the Gertrude and Ludwig Klein Memorial Fund and the General Fund funded a new "Be An Art Family" membership program.

The first workshop in November 2007 was "Reconstructing T-shirts" led by local youth artist Risa Bissenden. Families at subsequent workshops have drawn a family portrait, built birdhouses and created mosaic tiles for the Ross Street Plaza fountain.

Tracey Kutshchker, SAGA's administrator, describes the response to the program as "fantastic" with workshops filling up fast.



Family Learning Centre Opens

The Family Learning Centre at Salmon Arm West School held its official opening in December 2007 with a round dance, storytelling by First Nations Teacher-Counsellor, Meredith Rusk, and freshly baked bannock made by grandparent Linda Gaze.

A new program, the Family Learning Centre is open to children up to five years old plus their parent or caregiver. This free program is an opportunity for a child to learn early literacy, social, emotional, physical and cognitive development through play with carefully selected materials and activities. The program is under the guidance of Early Childhood Educator, Mary Regier.

The Centre serves the entire Salmon Arm region.

Purchase of toys and furnishing for the Centre was made possible by a \$5,000 grant from the Foundation's Wainwright-Mobley Memorial Fund and the General Fund. The program is supported by School District #83 and, in principle, by the Adams Lake Indian Band and the Neskonlith Lake Indian Band.

Ernie Braby

Ernie was born in 1921 in Sunderland. England. As the Second World War broke out he joined the Royal Air Force. After the war, he immigrated to Canada, first joining a brother in Vancouver and then coming to Salmon Arm to work as a mechanic in a local garage. In 1952, Ernie married a local girl, Kay Loring.

In 1960, Ernie opened his own business and took over the newly built Chevron station. In addition to operating the service station, he soon acquired a car agency and sold cars as well as served gas.

In 1964, he bought a failing American Motors dealership located west of town, where the present Braby Motors dealership operates. He retired in 1982 when his two sons took over the operation.

He had a strong sympathy for the "working man", was a true socialist and remained a card-carrying NDP member to his death.

Ernie died on January 18, 2008.



Morrie & Agnes Morrison

Morrie and Agnes Morrison are two of the Foundation's founders. In fact, Morrie says he and fellow founder Denis Marshall "cooked up the idea" of inviting founders for the brand new foundation less than a dozen years ago.

They had hoped for 20 to 25 people to give a minimum of \$1,000 each. "It caught fire" says Morrie and grew to 65 founders. With over \$76,000 –all in discretionary funds– the fledgling foundation was on its way.

Morrie served on the Foundation's board in the early years and recalls "We were a small but strong group of dedicated people setting the course. I took to it. It was such a good concept for the community and I wanted it to succeed."

No stranger to boards, Morrie was a senior vice-president of



the Royal Bank of Canada (in charge of 600 bank branches in Ontario) when he retired in 1984. He served on the executive of many not-for-profit organizations including Metropolitan Toronto and Region Conservation Foundation (chairman), Traffic Injury Research Foundation of Canada (vice-president), Canadian Cancer Society (national director), United Way of Greater Toronto, Advisory Committee of Doctors' Hospital, and Ontario Chamber of Commerce (president) and the Lions Club. After moving to

Shuswap Lake Estates, Morrie continued to be an active volunteer with many organizations including the Sorrento Lions Club, St. Mary's Anglican Church, Canadian Cancer Society and the Foundation.

Agnes was born in Salmon Arm. Her father farmed here until Agnes was 7 years old, when the family moved to Vancouver. She met Morrie after the war when he was attending UBC.

Agnes and Morrie celebrated their 60th wedding anniversary in 2007. They have three children.

It is with sadness that we report Morrie's passing on May 28, 2008.

A Gift with Some Strings Attached

Salmon Arm resident, Gabriele Klein, has discovered a way to achieve one of her long-term philanthropic goals by donating shares to Shuswap Community Foundation. And she will be able to take advantage of the significant tax benefits available to a donor who gives publicly traded securities (stocks or bonds) to a registered charity.

In 2003 Klein established the Gertrude and Ludwig Klein Memorial Fund with the Foundation to celebrate the lives of her parents. Income from the fund supports endeavours that foster world peace, the environment, the arts and sport: life-long passions of the Klein family.

Now with Klein's donation of shares to the family endowment fund, a portion of the income will be used to support an annual sponsorship for a first violin chair for Okanagan Symphony Society. Happily this will be the "core violin seat" currently occupied by Shuswap musician Susan Aylard of Sorrento. This is a fitting way to remember Klein's parents who were strong supporters of the Okanagan Symphony and were among the first subscribers in Salmon Arm.

For several years Klein had mulled over the idea of funding a chair with the symphony, but it's absence from the Shuswap had put her idea on the "back burner". However, she notes, the symphony has overcome recent challenges, retired a 5-year debt and now has a "fantastic new conductor, Rosemary Thomson, who really connects with the audience", and has plans in the "not too distant future" to perform in Salmon Arm.

Excited about the possibilities ahead, Klein is an example of a generous, community-minded person working with the Foundation to realize long-term financial goals through a family endowment fund. Klein notes, "This is a simple and cost effective alternative to establishing a private foundation."

Commenting on the recent donation, president Cindy Derkaz states, "We are thrilled to see families embracing the concept of the Foundation as a way to support their passions and enrich their community in perpetuity."

Elisabeth Thomi

Elisabeth Thomi was born in Bern, Switzerland, on April 3, 1922 and died in Salmon Arm May 29, 2007, at age 85.

She came to Canada in 1955 and worked for John Federer, an orchardist, who lived on North Broadview. Federer, who was also a Swiss, bequeathed the land to Elisabeth upon his death and she continued to operate the almost 35 acres for fruit, hay and honey production.

Salmon Arm resident Dorothy Hannebauer went to work for Elisabeth in 1974 thinning and picking apples and cherries. Over the years the two women became friends and Dorothy continued to work with Elisabeth every summer for the next 17 years.

She was a great animal lover, recalls Dorothy, who counted 13 cats and four dogs when she first came to the orchard. In her later years, Elisabeth gave regularly to the local SPCA and, upon her death, the SPCA took the last three cats and a special dog named Buddy. Buddy had survived a nasty encounter with a coyote and Dorothy says she was pleased when a retired couple adopted the animal. Elisabeth's house dog, Missy, died a few days after her owner and Dorothy believes the animal "died of a broken heart."

Shuswap Community Foundation received a substantial bequest of 2/3rds of the residue of Elisabeth Thomi's estate. The money has established the Elisabeth Thomi Endowment Fund with the annual income to be paid to the Shuswap Branch of the SPCA. Thanks to the generosity of Elisabeth Thomi, the Foundation's capital fund now exceeds \$3 million.

Catherine Ann Dilworth



Catherine Ann Dilworth was born in Kamloops on January 27, 1905. She was the daughter of British parents who met in Canada.

When Catherine's parents, John Dilworth and Kate McLaughlan, were married in Vancouver on January 8, 1902, John gave his address as the "Village of Kault".

Catherine's parents acquired a tract of land on the west side of Sorrento to develop a family farm. It is called the

Dilworth farm to this day. The land, once known as "Maplehurst Ranch", took many years to develop as it was cleared by hand.

Following in the footsteps of her mother to dedicate her life to others, this sensitive, soft spoken and gentle young lady decided in the early 1920's to become a registered nurse. By 1929, Catherine had graduated with honours from the Kamloops Hospital Academy of Nursing. She practised nursing in the Kamloops Hospital and then later moved to work at the B.C. Tranquille Sanitarium for Consumptive Patients about ten miles from Kamloops

She nursed in Vancouver for a number of years before moving to San Francisco, California, where she worked until the end of the 1960's. She retired and returned to Sorrento to care for her ninety-year-old mother.

In 1998, Catherine Dilworth moved to Bastion Place care facility in Salmon Arm. The staff there recalled her as a gracious and undemanding lady who was so very appreciative that made it very easy to do the little extras for her.

Catherine Dilworth passed away peacefully in Bastion Place in Salmon Arm on April 3, 2005 at the grand age of 100 years.

Catherine's Legacy

November 15, 2007, was National Philanthropy Day in Canada.

By a happy coincidence, it was also the day the Sorrento Lions Club presented a cheque for \$75,451 to Shuswap Community Foundation, bumping the Foundation's total capital over the \$2 million mark.

In 2005 Catherine Dilworth, a longtime resident of the South Shuswap community, bequeathed a substantial portion of the residue of her estate to the Lions Club and requested the money be used for the betterment of the community.

And the Lions Club did just that! In addition to the gift to the Foundation, they gave over \$174,000 to the Shuswap Lake Hospital Foundation's CT Scanner Fund.

Shuswap Community Foundation used the gift to establish a permanent endowment fund known as the "Sorrento Lions Club-Catherine Dilworth Memorial Endowment Fund."

Frank & Rita Smuin

Married in 1948 and living the early years of their married life in Beavermouth and West Summerland, Frank and Rita Smuin arrived in Salmon Arm in January 1954. It was the beginning of more than 50 years residency in Salmon Arm. Frank, who had joined the CPR following his demobilization from the RCAF at the end of WWII, was a Telegraph Operator while Rita was a Telephone Operator with BC Tel.

Frank spent more than 15 years at the CPR station on Front Street (now Lakeshore Drive) in Salmon Arm until he moved to Enderby as the station agent and then to a mobile supervisor position covering the Shuswap sub-division of the CPR. Frank enjoyed woodworking and over the years developed quite a wood shop in the basement of their home.

They stressed the need for education and always believed that the teachers of the Salmon Arm school district provided a first class education for their children. They both sacrificed many things to ensure that their three sons received post secondary educations.

When Rita passed away in 2001, Frank set up the Rita Smuin Memorial Bursary Fund.

Each year a bursary will be paid to a student entering post-secondary studies in health care, with a preference to a student intending to become a registered nurse. During her illness Rita was impressed with, and grateful for, the care and attention that she received. "Nurses," she told Frank "are very special people." This caused Frank to wonder what he could do to say thanks and to recognize the dedication displayed by nurses who cared so thoughtfully for Rita.

With Frank's passing in 2006, his sons Ken, Don and Terry wanted to honour their father along with their mother by adding to the fund and renaming it the "Frank and Rita Smuin Memorial Bursary Fund".

The community responded generously to add to the Peterson's gift. With only a couple of months before the deadline to apply for matching funds, the Heritage Association raised over \$75,000 which, with the matching funds, brought the total endowment fund to \$150,000.


