PRESIDENT'S MESSAGE

2017 has seen a continuation of growth for Shuswap Foundation both in the value of the portfolio and in the number of funds held by the Foundation. At year end, our investment portfolio was valued at \$8,887,036, up from \$8,008,968 in June of 2016, a gain of \$878,068. We have grown to 157 funds in our capital fund and an estimated \$385,000 in grants will be disbursed this coming year. Distribution of grants this year will see the Foundation pass the \$2 million mark since its inception. The vision of our Founders who wanted to see a philanthropic program designed to benefit our local area has certainly been achieved!

2016 saw a drop in the performance of our portfolio to 5.19%, due to soft market performance. This fiscal year we achieved a slightly better return of 5.56%. Our investment performance over the life of the portfolio with Mawer Investment Management is 12.2% at year end.

SCF participated in the Community

Fund for Canada's 150th; a collaboration with Community Foundations of Canada, the Government of Canada, and national philanthropic leaders. The purpose of the grant was to encourage participation in community initiatives, activities, and events to mark Canada's 150th. We encouraged small community groups planning events for 150th celebrations to apply for grants under this program in fall and spring cycles. A total of \$16,100 was granted to community groups to assist in their celebratory plans.

At the end of our fiscal year, the Foundation moved its office from Lakeshore Drive to Harbourfront Drive, where we share office facilities with Shuswap Community Futures. When you have an opportunity to visit the new offices, you will find access and parking much easier.

We are pleased to welcome Paige Hilland and Lindsay Wong as new directors to our Board this past year. Paige replaces Rod Bailey, and was a member of the original Youth Advisory

Committee of the Shuswap (YACOS) group in early 2000, so has experience with the workings of the Foundation. Lindsay, executive director of the DIA, replaces Lana Fitt, and brings a wealth of information on the commercial aspect of Salmon Arm to the Foundation. We also say goodbye and good luck to our Office Administrator, Paulette Brown, who has retired from the Foundation, and we welcome Paula Shields, our new Administrative Assistant.

The purchase of re-useable take out containers enables EVSMS to provide meals to the citizens of Sicamous and area, who are unable to attend the Meals Program in person. Delivered meals provides social contact to people who are unable to get out of their homes, which in turn, enables them to stay at home longer.

LYNDA NICHOLSON, ALLEN FERGUSON ENDOWMENT

"In Love with the Shuswap"

Life doesn't get much better than being able to choose your dream location and there make a life and career. This is exactly what Lynda Nicholson and Allen Ferguson did when they decided to move to Salmon Arm. Both Lynda and Allen lived

and worked in Revelstoke: Lynda as a teacher and Allen as a massage therapist. Allen had also established a practice in Salmon Arm and when that practice grew and Lynda secured a teaching position in fall of 1990, they moved.

Lynda was born and raised in Kamloops while Allen hails from the Ottawa area. East met west

in Revelstoke through their shared interest in fitness, health, sport, and travel. Allen's criteria for living in Salmon Arm were: no commuting, no bag lunches, and a view of the lake. So in 1991 and 1992 they purchased the building on Lakeshore that now houses Shoes N Such, the massage clinic, and their home. They admit that downtown living has health and environmental benefits when they can walk to shopping and cultural events. From their perfect vantage point they take pleasure in keeping an eye on nesting osprey and other water birds.

Lynda's teaching career included elementary then junior high, and active involvement supporting teachers through their professional union. Over the years Allen's massage practice grew to include other massage therapists. Lynda retired in 2008 and serves on the board of the Salmon Arm Golf Club. Allen retired in 2010, and both have overseen several major renovations to their building.

Lynda and Allen are sports enthusiasts, both as participants and spectators. They love to run, hike, walk, bike, kayak, and play golf, and have made a commitment to fitness. They enjoy travel and often organize trips around special sports events such as the tennis grand slams. With their kayaks and bicycles on their small motor home they look for interesting

bodies of water and cycling trails. They call themselves 'freestyle vacationers' and let the adventure unfold depending on the weather. They also enjoy cities where they walk and use public transportation with the goal of leaving the smallest footprint possible.

Allen and Lynda feel so very fortunate in their careers and their life in Salmon Arm and felt it was

time to support the community through a legacy. They know that all the amenities they enjoy do not happen by magic, but rather through the efforts of dedicated volunteers and community members.

In January 2015 they established the Lynda Nicholson, Allen Ferguson Fund with the Shuswap Community Foundation. At first they designated interests, but when they learned about the Foundation's Matching Funds Program they changed their fund to discretionary to allow Foundation directors to assign the proceeds from their fund to the areas of greatest need.

Both Lynda and Allen describe this area as "a rich and wonderful smorgasbord of natural beauty with cultural and sport opportunities." As for the future: "This is it," they say. "It's perfect."



Through the construction of "Little Free Libraries" LASS will continue to promote literacy through ready accessibility of free books and will positively affect shared public spaces by cultivating generosity and responsible citizenship and by providing a non-digital experience within our community.

PAUL AND JANE BURROWS ENDOWMENT

In 2000, after careful research and consideration of the amenities they considered necessary to a comfortable retirement, Paul and Jane Burrows uprooted themselves from Whistler, BC, their home for 30 years, and moved to Salmon Arm. They became active members of the community.

Jane, née Archer, was born in Kirkland Lake, ON. She at-

tended Ryerson University, obtaining a degree in 1963, and then starting a career in Marketing Research. Paul was born in York, England, and later moved to Ireland, then Rhodesia, now Zimbabwe.

After completing high school in South Africa, two years in Medicine at the University of CapeTown, he entered the printing trade. In 1959 he was sent to the London School of Printing by his employer, Rhodesian Printers, to

complete his training as a printer at the Polytechnic School in Salisbury, Rhodesia, and from there, in 1960, he chose to move to Toronto, Canada, where he went to work for Rolph-Clark-Stone Limited.

The couple met in Vancouver, where Jane was attending UBC in order to obtain her teaching degree, having become disenchanted with the ethics of the marketing world, and Paul was now working for PrintCraft in Burnaby. They married in 1971 and moved to Whistler, where Paul had built a 'cabin.' Jane pursued her career as a primary school teacher, first in Britannia Beach, then Pemberton, and retired from her school in Whistler in 1997. Paul worked on the mountain for the next 20 years, as a member of the ski patrol and a mountain guide/host, as well as in the construction industry. He became active in Whistler politics, serving two terms as an alderman and six years

as a school trustee. He was also president of the Whistler Ratepayers Association for several years.

In 1976, Jane and Paul began a new venture, creating "The Whistler Question," a small local newspaper still in publication on a weekly basis today. They sold the business in 1983, but Paul continued writing his 'Burrowings' opinion column until 1999, when they began planning their

retirement move. They had been active with the Whistler Blackcomb Community Foundation, and had met Cindy Derkaz at a conference. When they made the move to Salmon Arm, they contacted Cindy, who introduced them to Shuswap Community Foundation.

Believing strongly in the need to preserve the natural environment of the Shuswap, and the importance of protecting Shuswap Lake, they recently decided to create their own endowment fund, the Paul and

Jane Burrows Endowment. Income from the fund will be given as grants to qualified charitable organizations in the Shuswap for projects which benefit the environment, as well as to those entering a field of environmental studies, or which address environmental issues. The directors of the foundation will have the discretion to award grants should there not be a qualified request or recipient in any particular year. Paul says they hope to 'do a little good' for Salmon Arm, and help others get involved in the issues that will keep the community vibrant and growing as an unspoiled attraction on the shores of Shuswap Lake. The fund is open to further donations.

"Whatever intervention we can provide for some younger person to get involved and use their thinking to see what the issues are and to solve those issues," says Paul. "If we've helped to do that, then we'll have succeeded."



Pirate Loppet Committee Project: School Nordic Ski Program

This grant was used to help outfit six schools in the area with ski equipment to enable the training of Nordic skiing and to participate in the Children's Pirate Loppet. The Pirate Loppet Committee, with the support of School District #83, volunteers, and sponsors, have hosted a Children's Pirate Loppet for over 400 Grade 3 to 7 students for many years. This grant was made possible by the Wainwright Mobley Memorial Endowment.

COMMUNITY FUND FOR

The Community Fund for Canada's 150th was a collaboration led by Community Foundations of Canada and the national network of 191 community foundations, together with support from the Government of Canada and extraordinary philanthropic leaders from coast to coast to coast.

The Okanagan Regional Library - Shuswap Endowment

Currently there are five Okanagan Regional Library (ORL) locations in the Shuswap: Salmon Arm Branch

in Piccadilly Mall, South Shuswap Branch in Blind Bay, North Shuswap Branch in Scotch Creek, Silver Creek Branch, and the Sicamous Branch.

In 2016, ORL contributed \$5,000 to establish a permanent endowment with Shuswap Community Foundation. When the endowment reaches \$10,000, income earned will be used to support library services and programs in the Shuswap region. "We recognize the importance of libraries in the Shuswap communities, and in planning for their future, we wanted to cre-

ate an endowment to support library services," explained ORL Board Chair, Catherine Lord of Vernon.

"We hope this endowment encourages local residents to invest in the sustainability of their library."

MAURICE GILLIS MEMORIAL ENDOWMENT

Maurice Gillis died in 1967 but he lives on in the history of Sicamous, having spent most of his life there. He arrived in the area around 1910 from Cape Breton.

His first entrepreneurial venture started in Seymour Arm in 1912 when he acquired a section of meadowland. With the help of

his friend, Jim Munro, he proceeded to drain it so it could be used as hay land for the pack trains en route to a mine north east of Seymour Arm. The mine never materialized but Gillis Meadows and Gillis Lake still exist today. His sights then turned to tourism; he and Leo McLeod purchased the launch MV Anavana, offering sightseeing trips around the Shuswap.

Maurice enlisted in the armed forces during the First World War and was subsequently assigned to the Siberian Expeditionary Force. The war ended before he was deployed so he returned to Sicamous. He became the manager of the Bellevue Hotel, operated a boat livery service, and during the summer months ran a sightseeing and guided fishing service using his luxury launch, the Tourist. His many clients, who arrived by train from all over the world, were promised a true wilderness adventure and no shortage of fish. One such client was His Highness the Maharajah of Jind and his entourage. So pleased was he with his catch, the monarch had his rainbow trout mounted and forwarded to his palace in India. You might say Maurice was a pioneer of the tourist business in Sicamous.

In 1919, Maurice married Marjorie Thomas of Vancouver. They had two children, June and Glenna. In 1922 the family moved from the Bellevue Hotel to lakeshore property directly west of the CPR Hotel. After eight years Marjorie moved back to Vancouver

with the girls, but June and Glenna always looked forward to summer holidays when they would return to Sicamous and the beach. Maurice continued to operate his business from that location until a fire destroyed the home in 1936. He then purchased 155 acres on Mara Lake. The land

extended from Sicamous Narrows (Sicamous Channel) to one mile south on Mara Lake. His business, now named Fort Gillis Fishing Camp, expanded to include "comfortable cabins." He advertised special rates for excursions and fishing parties, and his motto was "No Fish, No Pay."

When a restriction on gasoline

for pleasure use was imposed during the 2nd World War, Maurice moved to Vancouver and worked in the shipyards. After the war, Fort Gillis and 38 acres of land were sold and renamed White Pine Resort. In the ensuing years he developed a subdivision on the north side of Hwy. 97A, and subdivided and sold his remaining three-quarter mile stretch of lakeshore property.

Maurice Gillis was a perspicacious businessman who knew how to make a buck but he lived a frugal personal life. His home up until the time he died was a small cabin on the bay next to a creek, which both bear his name.

Maurice's granddaughter, Janice Turner, has created a memorial endowment fund in his name with Shuswap Community Foundation to honour and commemorate his contribution to the development of Sicamous. Income earned on the Fund will be disbursed annually, at the discretion of the directors of the foundation, to award one or more grants to qualified charitable organizations operating in the Sicamous/Malakwa area.

The fund welcomes donations at any time.



Shuswap Association of Writers Word on the Lake Writers' Festival

A major literary event in the interior of British Columbia, this festival brings together writers, readers, published authors, publishers, and editors in an exciting and stimulating three-day festival hosted by the Shuswap Association of Writers. The Eagle Valley Rescue Society Rope Rescue Training

EVRS serves Sicamous and the surrounding area. Twenty per cent of all calls involve rescue from steep embankments or mountains requiring the use of ropes. This grant was used to provide training in rope rescue to its members.

READY FAMILY ENDOWMENT

In 1965 Shayne and Holly Ready moved their young family, Blane, Regan and Diane to Salmon Arm to set up their own business. They purchased Hunter's Pharmacy at the corner of Hudson and Alexander and renamed it Ready's Drug and Camera Company to allow for both their professions and passions.

Holly grew up in Cumberland on Vancouver Island while Shayne grew up in North Vancouver. They met in the UBC Biology Lab and married a week after receiving their Pharmacy degrees in 1952. Holly received

the BC Pharmacy Association Prize for most outstanding record in practical and theoretical pharmacy subjects. A generation later, son Blane followed in his mother's footsteps and received the same award.

Soon Ready's Sorrento Prescriptions was opened. Both sons studied pharmacy at UBC, worked at Ready's and eventually struck out on their own. Regan ran the Sorrento store and Blane went to Shoppers in Piccadilly Mall and eventually took over the franchise.

Shayne's passion was photography—he was a photographer with the Vancouver Sun in his teens. Once married, Shane and Holly photographed weddings and made up albums. Holly's passion was art and fortunately her piano teacher was also an accredited art teacher who taught her watercolour painting. Holly took fine arts courses at Okanagan College and participated in a College exhibition at the Vernon Art Gallery.

The Ready family played an active part in Salmon Arm community life. For many years Shayne was on the Downtown Parking Commission, a member of the Downtown Improvement Association, and a Rotarian. He was a Gilwell Scouter and assistant scoutmaster for the 1st Salmon Arm Scout Troop and a member of the Masonic Lodge and Royal Arch Masons. He was also a certified scuba diver.



Holly belonged to the Order of the Eastern Star and the Daughters of the Nile. She was a founding member of the West Vancouver sketch Club and the Salmon Arm Paint and Sketch Club and has been a long time supporter and member of the Salmon Arm Art Gallery where she participated in many exhibitions. Holly took Hospice and Healing Touch Training and Tai Chi classes.

Shayne retired in 1994 and passed away in 2004. Holly remained in the business until she sold it to Pharmasave. In 2007 Holly sold the family home and moved into "Gabe's Bunkhouse" near the United Church. After many renovations she named her new home "Heartsong" where she enjoys reading, art, music, her garden and visits from her grandchildren.

Holly said "we enjoyed having the drugstore here and appreciated the support of the community—we liked the small town atmosphere". When friend Tom Brighouse was involved in establishing a Community Foundation Holly and Shayne realized that being founders would be the perfect way to give back to the community that supported them for so many years. In 2007, Holly decided to support in perpetuity, two organizations close to her heart, the SAFE Society and Shuswap Hospice Society, and established the Ready Family Endowment.
