# President's Message

2017/18 has seen the continued growth in Shuswap Foundation's Capital Account, both in the value of the portfolio and in the number of funds held by the Foundation. At year end, our investment portfolio was valued at \$9,289,059, up from \$8,887,036 in June of 2018, a gain of \$402,023, and we now have 164 funds in our Capital Fund. Distribution of grants this year will see the Foundation pass the \$2.5 million mark since its inception.

This fiscal year we achieved a return of 7.3%. At year end, our investment performance over the life of the portfolio with Mawer Investment Management was 11.2%.


The Foundation's move to Harbourfront Drive has proven very beneficial, with visitors commenting on how much easier it is to visit our office. When you have an opportunity to visit the new office, you will find access and parking much better.

We are very pleased to welcome Roger Parenteau as our Foundation Manager. Roger has made a big difference in the operation of the Foundation, and has taken on many much needed tasks such as replacing our website, and building a charitable organization/not-for-profit data base which will enable us to increase our granting capacity. He is also investigating software to improve our donor/granting reporting. Anyone who has visited the Foundation office will know Paula Shields, our wonderful Administrative Assistant.

This is my final report as President as I will pass the mantle on to Bryan Kassa at our Annual General Meeting in October 2018. I will continue as a Director. I have enjoyed my time as President, and have had the good fortune of working with a hard-working Board of Directors.

# Funder Profile - Gordon Priestman

August 4, 1936 - August 4, 2003

For more than three decades Gordon Priestman documented the events and people that shaped Salmon Arm while producing work of the highest journalistic quality. With his full beard and piercing eyes, he was instantly recognizable - the very image of the dignified newspaper editor.

Gord was a true friend of Salmon Arm. He observed, and loved to chat with, people, then shared his experiences with the community and gave needed perspective. He called on residents to live with integrity and honour; challenged those in power; spoke for those without a voice and above all treasured free speech and encouraged debate.

Born and raised in Ontario, Gord moved to BC in 1964 and began his career in journalism, coming to Salmon Arm in 1967 to become the editor of the Salmon Arm Observer, a position he held for 33 years. A lifelong social democrat, he took a leave of absence to run for the NDP in the 1996 provincial election. He then returned to the Observer, retiring for health reasons in December, 1998.

Gordon was always interested in the arts—writing, music and painting. He loved the outdoors, including camping, canoeing and observing nature. Until his middle years he was active in a number of sports. He was involved with numerous local organizations, was a member of the Salmar Community Association, and a life member of the Fall Fair Society. When he died in 2003, he was serving his second term as a Director of Shuswap Community Foundation. It was Gord who suggested the Foundation's former motto, "Promises for Tomorrow."

The Gordon Priestman Memorial Endowment has been established and is open to all donations. Proceeds from the fund will be disbursed at the discretion of the Foundation's directors in support of community projects, thus ensuring Gord's legacy for all the tomorrows to come.

# Funder Profile - Allan and Rosemary Wilson

Through love of the Shuswap community, demonstrated by decades of volunteer work, both Allan and Rosemary Wilson exemplify what it means to be a Community Champion: a person who identifies a need in his or her community and works in whatever way he or she can to contribute to the growth of that community and the support of its residents.



Allan and Rosemary were married in 1968, and moved to Tappen in 1969. This was the start of a life journey together built on love, and a shared interest in history and community building. Rosemary held down the fort at home, running the family farm and eventually raising as many as 35 sows, while Allan worked as a mechanic at the Federated Co-op sawmill in Canoe. Their two children, Mae and Philip, were born in 1971 and 1975, respectively.

Rosemary, who passed away in 2017, was an active member of the Shuswap community whose lifetime contributions continue to benefit residents of the Shuswap. Allan carries on the work that they both found so fulfilling. If you meet him, you will learn that he is a fountain of information, and he will regale you with stories that leave you laughing, and feeling lucky to call the Shuswap community home.

Having worked tirelessly with the Tappen Co-op, the Okanagan Historical Society, and R.J. Haney Heritage Village and Museum both Allan and Rosemary had an insider's knowledge of the resources required to ensure these organizations could carry out their mandate. Shuswap Community Foundation is grateful to Allan and the late Rosemary Wilson for their generous donation establishing the Allan and Rosemary Wilson Preserving Memories Fund that will benefit residents of the Shuswap for a very long time to come.

Income from the Fund will be disbursed annually to award one or more grants to charitable organizations operating in the Shuswap area, providing funds for:

- purchasing archival supplies for museums located in the Shuswap area, including Salmon Arm, Sicamous, North Shuswap, and Falkland;
- Maintaining or enhancing the Tappen Cemetery;
- Researching and writing historical accounts of the Shuswap area.

# Funder Profile - Fred and Alice Duck

In 1991, on the July long weekend, Fred and Alice Duck became residents of Sicamous, BC, where Fred took up his position as the United Church Lay Pastoral Minister. He retired in 2004.

Fred and Alice met on a blind date. Alice told her best friend, "His name is Fred Duck, and if I marry him, I'll be A. Duck for the rest of my life. – ain't gonna happen." Well it did, on June 24, 1977. They've had lots of fun with the name over the years. In Kamloops they lived on Chukar Drive, with neighbours John and Jean Crowe, and Della and Jerry Swallow.

Once settled in their new home in Sicamous, they became very involved in their new Shuswap community. Alice is a founding board member of the Eagle Valley Community Support Centre, sat on the board of directors of SASCU for 16 years, was a director on the board of Shuswap Community Foundation for 15 years, and is currently on the board of the Salmon Arm Hospice Society. Fred is the Sicamous Legion Chaplain, a past president of Salmon Arm Hospice Society, and is currently actively involved with the Royal Canadian Marine Search & Rescue, stationed in Sicamous. They are both past presidents of Probus Shuswap. Both volunteer in the very successful Sicamous United Church Thrift Store where you will find them every Wednesday morning.

Alice and Fred have each left a legacy gift to Shuswap Community Foundation in their wills, but when they learned of the opportunity to open an endowment fund via the foundation's 'Matching Funds' program, they took it. They decided to do this because, as Fred said, "We've been lucky in our lives and don't want for anything. We want to help support a strong financial foundation for the future of SCF, in perpetuity." Alice added, "We did it because it's a good thing to do, and the foundation is the perfect vehicle to give back to Shuswap communities in the areas most needed."

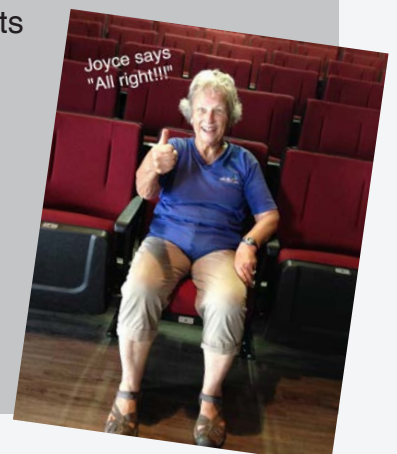

## Project Profile - Shuswap Theatre

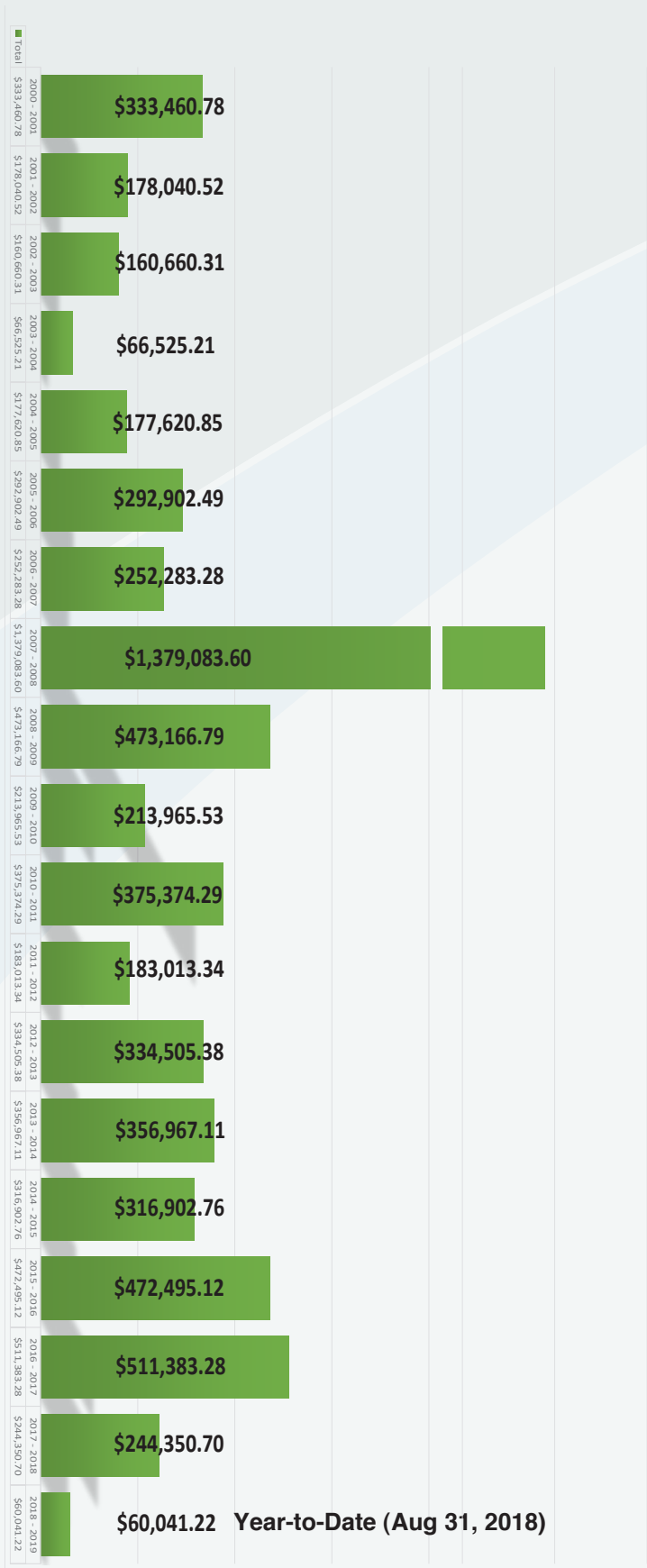

## SCF Donations year-to-year since 2000



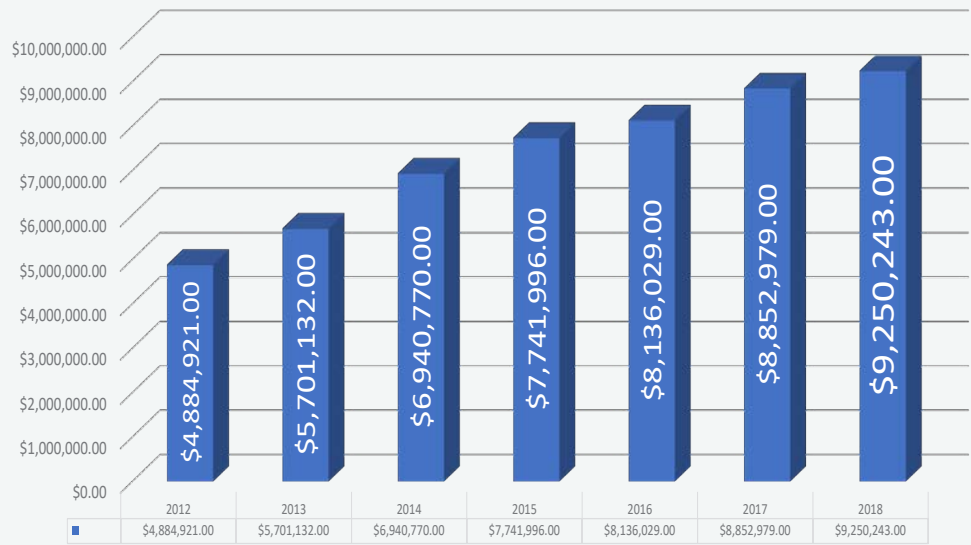

# Funder Profile - Al Neale & Beryl Herdan

Al Neale and Beryl Herdan couldn't think of a better way to express their gratitude. Their endowment funds to the Canadian Mental Health Association (CHMA) were established with two goals in mind:



- to support operational costs of the organization and;
- to support families who have a loved one suffering with mental health issues.

Beryl has a daughter and a grandson who live day by day with bipolar disorder, and Al has an adopted daughter who suffers from fetal alcohol syndrome. The support they have received over the years from CHMA gave them strategies to help their relationships with their children. "We got to know as much as we could about mental health to help us understand it," says Al.

For Beryl, CHMA helped her see beyond her daughter's mental illness and appreciate who she is as a person, and to view things from her daughter's point of view. "I just loved that girl and I could see the positive and the creative. They helped me to understand the illness.

Their effort to connect with loved ones, to learn about mental illness and how to deal with it, was a bond that strengthened Al's and Beryl's relationship. Both had lost their spouses and moved to the Shuswap in the late 70s. "In Calgary I was always in a shell. When I came out here and met people in Cedar Heights it was like a big family," says Al.

Beryl had moved to Salmon Arm, where she met her second husband, Rudi. After he passed away Beryl met Al. Soon they were enjoying each other's company and becoming very engaged in the community: square dancing, singing, acting, attending the local story-telling group, and the historical society.

For Beryl and Al, knowing their gift will help other families live life to the fullest is a legacy they're proud to leave. "I can sympathize with the person who is an alcoholic or a person with mental health issues. They don't get up in the morning and say, 'I'm going to be an alcoholic' or 'I'm going to be a person with mental health issues today,'" says Beryl. "We can't do anything but learn more about it and be compassionate."

As CHMA gave them the tools they needed, so their gifts will help other families flourish regardless of mental health problems.

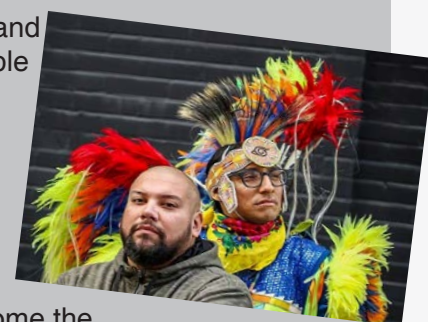

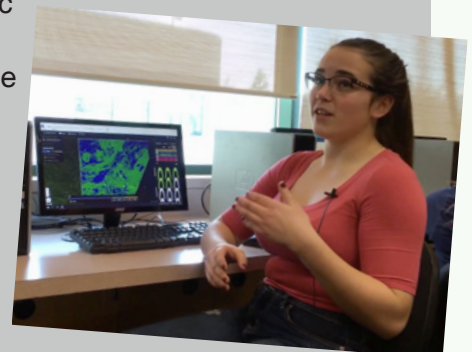

# Founders Profile - Joan & Denis Marshall

## A Passion for Our History

Joan Marshall's roots go back to the 1880s when her Finnish great-grandfather, Kusta Laitinen, came to work as a section foreman on the CPR. One of Kusta's daughters, Joan's grandmother, married an Englishman, Bill Holliday, who named Piccadilly Road and Rotten Row after the same streets in London, England. Joan trained as a teacher, then had three daughters with her 'handsome Mountie' husband.

Joan knew Denis Marshall since Grade 6 at Salmon Arm Elementary. When Joan, now a single mom of three daughters in Vernon, attended a retirement party for her Grade 1 teacher, Miss Fawcett, Denis covered the event for the *Observer*. This marked the start of their romance and a happy 40-year marriage.

In 1944, Frank and Laura Marshall bought the *Salmon Arm Observer*. Denis worked in the family business full time from 1953 to 1976. After his father's death in 1964 he became the Publisher and got to know 'everyone' in Salmon Arm while reporting on and documenting local events, and developing a passion for local history.

In 1976 Joan and Denis sold the *Observer* to Ian and Lynn Wickett and moved to the coast, but the Shuswap drew them back in 1993. Joan served on the Board of the Art Gallery for several years while Denis put his love for local history to work with the Salmon Arm Branch of the Okanagan Historical Society as its long-time treasurer. He also wrote four books on community history.

Denis loved to hike and bike in the outdoors. Joan relates that her first gift from Denis was a good pair of hiking boots. Joan says she 'went along for the ride' and enjoyed every minute with Denis and his passion for history.

Denis' vision and love for community made him a natural as one of the earliest Board Members and ardent promoter of the Shuswap Community Foundation.
